

Accordingly, POWERGRID Aligarh Sikar Transmission Limited (A 100% wholly owned subsidiary of Power Grid Corporation of India Limited) has been nominated for construction and maintenance of 765 KV D/C Bhadla-II to Sikar-II Transmission line.

The construction works of the subject TL are going on in full swing except in forest area. A proposal seeking for clearances from Forest dept. was submitted vide proposal no. FP/RJ/TRANS/142545/2021 on 01.06.2021 (Online). Due to change in Substation location, line length of the under-construction TL is decreased and also line is not crossing NH-52 (Sikar -Jaipur). Therefore, no involved of social forestry in Sikar district. It is pertinent to mention here that there is no change of forest area in Jodhpur & Nagaur district.

Therefore, in view of above, you are requested to kindly allow to mark the proposal to user agency so that proposal can be edited for not to include forest involving in Sikar district for the construction of 765 KV D/C Bhadla-II to Sikar-II Transmission line.
