In this context, vide policy circular dated 06.03.2020 guidelines have been issued for inclusion of utility shifting works in the RFPs/Bids as part of civil construction under Hybrid Annuity and EPC mode. Amendment to circular dated 06.03.2020 has been issued vide circular dated 13.10.2020. Further, vide NHAI policy circular dated 08.07.2020, guidelines have been issued regarding adequacy and effectiveness of drainage system. Para 2(iv) of this circular deals with the projects for which bids are yet to be invited.

4. Accordingly, you are requested to submit the bid documents for subject project to be taken up on EPC mode duly incorporating the guidelines mentioned under aforesaid circulars and other applicable circular at earliest for further necessary action.
