



JOINT INSEPECTION REPORT


Joint inspection of site for diversion of land for construction of **Bridge and Pipe line at Duttnagar** in Tehsil Rampur Bushahr under LWSS Augmentation and Integration of VWSS Matiyana, Kumarsain and surrounding area of Shimla District was done on **28/11/2014**.

Two possible alignments/sites were proposed by the user agency for construction of Brigde and Pipe line at Duttnagar. Both these sites comprises Govt./Forest land. In the alignment No.1, Govt./ forest land involved for diversion is 0-42-90 hectare and no tree will require removal. In the second alignments/site, 0-45-00 hac Govt./forest land and no trees will require removal. Keeping in view of the minimum area and minimum felling of trees Joint Inspection Committee is of the view that diversion of coming in the alignment No. 1 is suitable. Since alignment -I involve less forest land and entails no felling of trees and there are Govt./forest land interspersed in both the alignments, there is no scope for avoidance of Govt./forest land and diversion of 0-42-90 ha. of Govt./forest is bare minimum and cannot be escaped.

The Joint Inspection Committee, therefore, recommends that the Govt./forest land measuring area 0-42-90 ha. coming in the alignment No. 1 as detailed in Check list-6 enclosed as Annexure-I be diverted under Forest (Conservation) Act, 1980 for construction of **Bridge and Pipe line at Duttnagar**, Tehsil Rampur Bushahr, Distt. Shimla H.P.
