- 4. This administrative approval is issued on the condition that the instruction issued by Punjab Govt. about the Punjab state cancer and drug addiction treatment infrastructure fund and culture heritage maintenance and development fund should be considered.
- 5. The provision of the 0.5% contingency, 1% culture cess. Total 1.5% should be made in the estimate.
