STATEMENT OF CASE

Proposal for Diversion of 52.45 Hectare of Forest land for improvement of Akajan-Likabali - Bame Road from km 71.00 to km 95.00 To NHDL specification under Aalo forest territorial Division in west Siang district of Arunachal Pradesh.

- The Road Akajan- Likabali Bame Road also was included in the BRDB programmer in 1962 for Construction to Cl-09 Surface specification. The responsibility for its construction & maintenance was entrusted to BRO. Presently the Road is maintained under scale –I maintenance grant.
- 2. The A L B passes through plain ,hill/mountainous terrain with moderate forest growth .The area experience heavy rainfall having annual rainfall of more than 250mm in a year and temperature varies from 4deg Celsius to 40 deg Celsius. The road passes between altitudes of 350m to 985m above M S L.
- 3. The road Akajn –Likabale –Bame Road is a vital link and the line of communication for the local inhabitants of the forward areas of the district Upper Subhansiri, West Siang, East Siang, and Upper Siang of Arunachal Pradesh. Most of socio economical development of above referred district of Arunachal Pradesh depends on communication through this road. The improvement of road from its present state of NHDL specification will also enhance the strategic build up in this area apart from socio economic development of Arunachal Pradesh.
- 4. The road Akajn Likabale Bame Road km 71 km 95 has been proposed for improvement to NHDL specification from present clause -9 specifications under SARDP NE, phase –B, program. Approval for initiation of DPR has been received from MORTH vide this letter number RW/NH-12037/76/2004/NER/NH-10, date 23 November 2006.
- 5. The improvement of clause -9 roads to NHDL specification has been purposed to be taken up in stretches of 20 30 km length for easy execution is early completion of job. Accordingly DPR is under process and being forwarded for obtaining Government sanction. Similarly the proposal for obtaining forest clearances has been prepared for the same length and submitted hear with as the cost of CA and NPV for the whole length of road cannot be afforded and accommodated in one job.
- 6. The proposal from km 71.00 km 95.00 on Akajn Likabale Bame Road has been prepared as per revised forest conservation Rule 2003, under forest conservation Act 1980 for obtaining forest clearance from Government of India. As per proposed 24-45 width of ROW in forest area and 24 m width of ROW in built up area are required for improvement of road as per NHDL specification of MORTH. Whereas the existing single lane clause -9 road between km 71 –km 95 has only 15 m width of Right of Way.

Therefore for the improvement of road as per NHDL specification there is additional requirement of 9 m width (24-15 = 9m) of right of way in urban areas and (24m to 35m - 15 = 9 to 20m) right of way in forest area for which unclassified forest land is to be acquired.

- 7. Approximately 96000 cum per km of Muck will be the generated and disposed off in private land or within ROW as side filling during the improvement, with this rate total quantity is 2300000 cum Muck will be disposed for cutting in 24 km. Out of this 30 % of Muck will be utilized to side filling and raising the level of the road in fill section. Hence the quantity of unusable Muck which is to be disposed of is at the rate of 70% of 2300000 i.e. 1610000cum for this disposal of 202000 sqm of land is being requisitioned in addition to the land required for construction of road. Location of Muck disposal sites amounting to 20.2 Hectare is marked on SOI Topo sheet. The muck will be transported duly covered with tarpaulin to avoid environmental pollution.
- 8. As such the subject proposal has been prepared as per revised Rule 2003 under forest conservation Act 1980, for obtaining forest clearance from Govt. of India for diversion of forest land for non forestry purpose for the balance of road i.e. from km 71 to km 95 from Road Akajan Likabali Bame Aalo Road.
- 9. In view of importance of the project on early clearance is required please.
