The Optical fiber cables are always laid along the road side due to easy supervision, quick maintenance, and low cost of maintenance. Laying of Cable shall be done on a 0.45cm width of surface land, & up to 1.65 metres of depth and near to the extreme road boundary where alignment of trench will be done in such way that no tree will be required to be cut.
