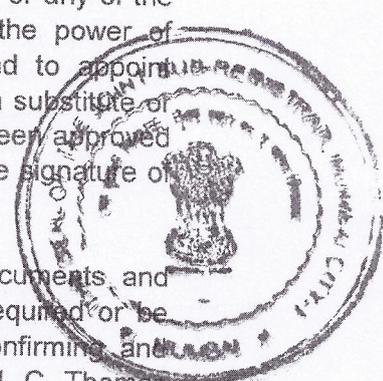

Subject to the conditions specified in para 2 above, to grant all sanctions and authorities to other duly empowered officers of the Company under him for exercising such power and authorities and doing such acts, deeds and things for and on behalf of the Company as shall require the sanction of the Company and in particular to grant such sanctions and authorities to such officers of the Company for and in respect of the exercise of the following powers and authorities by them respectively on behalf of the Company :-

The institution, conduct, defend, compromise, reference to arbitration, abandonment and carrying to appeal and final execution of all legal and other proceedings.

4. To sign and execute all leases (whether as lessor or lessee) licences (whether as grantor or grantee) and accept all conveyances and assurances whatsoever, which have been approved by the Board, Managing Director or any Executive Director of the Company.
5. To lodge for registration and admit execution and identify the Seal of the Company before the Registrar or Sub-Registrar or other officer of all agreements, deeds, conveyances, exchanges, mortgages, re-conveyances, leases, surrenders, releases and other instruments and assurances of any kind whatsoever executed by the Company as in the opinion of the Attorney shall be necessary or expedient in connection with the affairs and properties of the Company as aforesaid and to do all acts, deeds and things necessary in that behalf for enforcing the registration in accordance with the law of the time-being in force of all deeds and documents in which the Company may be interested or concerned.
6. TO SIGN all correspondence that may be necessary in the ordinary course of business of the Company.
7. TO APPOINT from time to time as occasion may arise one or more substitute or substitutes under him the said Attorneys to have and exercise all or any of the powers conferred by these presents (other than and except the power of substitution) and to remove such substitute or substitutes and to appoint another or other in his or their stead PROVIDED that every such substitute or substitutes as aforesaid shall previous to his appointment have been approved on behalf of the Company by a memorandum or writing under the signature of the Managing Director or any Executive Director.

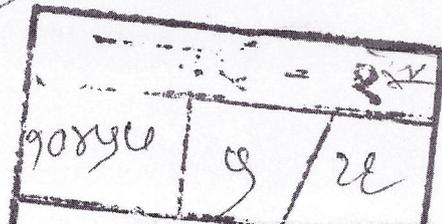
