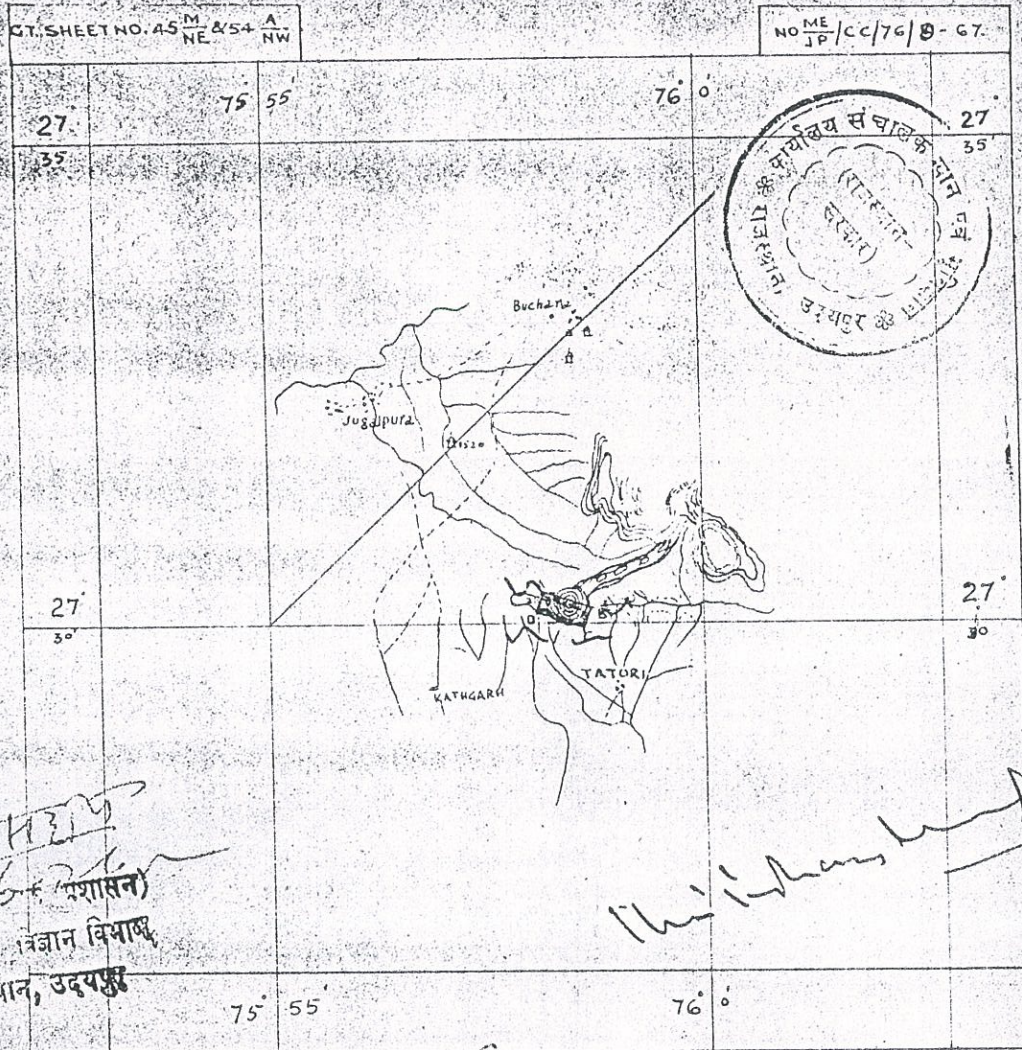


MAP SHOWING DEMARCATED AREA (ML-22/66) FOR CHINA CLAY

My dear Shri Mathur Sahab!

This has reference to the discussions held with you on 17.12.96 in the Chamber of the Chief Secretary Rajasthan regarding the clearance of proposals for de-reservation of the forest lands covered under existing mining leases/quarry Licences.

In this context I would like to inform you that the Mines Department takes full responsibility to ensure that once a decision is taken by the Forest Department to dereserve forest land for mining purposes, the cost of compensatory afforestation will be deposited by the concerned lease holders.

The Mines Department also undertakes that the alternate land required for compensatory afforestation shall be made available immediately after the decision regarding de-reservation of forest land is conveyed to the Mines Department.

I am sure appropriate directions must have been given to the Officers of the Forest Department from your Office to ensure speedy disposal of all pending cases.
