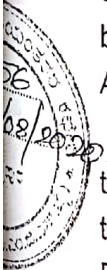
### Preamble :

The Empowered Committee under the Chairmanship of Secretary, MORD, Govt of India has cleared the project proposal comprising of.445 road works and 26 long span bridges under PMGSY III Batch I for upgradation for a length of 3226.21 km in 27 Districts of Karnataka State at an estimated cost of Rs. 2169.72 Crores for the year 2019-20 vide reference 1.

The Govt. of Karnataka vide reference cited at Sl. No:(2) above has accorded administrative approval to take up these works for execution through e-Procurement as per KTPP act.

The Detailed Project Reports in respect of 445 roads for a length of 3226.21 km and 26 long span Bridges in 27 Districts, costing of Rs. 2169.72 crores have been prepared based on the guidelines issued by the Ministry of Rural Development, New Delhi. The same have been scrutinized & certified by the State Technical Agency. These projects have been accorded technical sanction by Karnataka Rural Road Development Agency

These Works have been packaged based on the local conditions and there are 305 Packages in the Batch I of PMGSY III. In this package there are 1 works. The Superintending Engineer, Bangalore Circle, Bangalore has submitted the estimates based on the Schedule of Rates of 2019-20 for technical sanction. These works have been scrutinized and accorded technical sanction in this office for Rs.11,20,00,000.00 under CER No. 431/2020-21,

The Supeintending Engineer has submitted the Draft Tender Schedule for this package and the same has been approved in this office.


a) Rates quoted by the contractor shall be verified once again and if there is any freak rates that shall be rationalized.
