We invite your kind attention to the subject and reference cited above. We inform you that, as per the directions received from the Principal Chief Conservator of Forests, that "for proposals which are not passing through the existing Right of Way (RoW), including non-notified roads, the equivalent Non-Forest Land (NFL) needs to be identified and transferred to the State Forest Department for taking further necessary action".

We submit that T-Fiber has already initiated the process of identification of the land centrally in one place for the entire project. The Prl. Secretary, ITE&C department vide reference cited above, has requested the Chief Commissioner of Land Administration (CCLA), Telangana State to provide the details of the land bank, which could be issued as NFL to the forest department. T-Fiber project was declared as 'Vital Public Purpose Project', hence completion of T-Fiber project is very crucial.

We request you to consider this as an **Undertaking** that the required NFL to be transferred against the proposals submitted pertaining to Asifabad Forest division(3.6019 Ha). We request you, to process the proposals submitted for RoW permissions.

As you are aware that the Government of Telangana has incorporated an SPV, Telangana Fiber Grid Corporation Ltd., ("T-Fiber") as a State implementing agency to establish a state-of-the-art digital network infrastructure that is long-lasting, resilient, secure, scalable, and carrier-grade to provide affordable, high speed broadband connectivity from State Headquarters to all homes, government offices and enterprises in the State of Telangana.

As part of project implementation, RoW permissions are required from various State and Central departments like Forest, NHAI, GAS, etc. Accordingly, proposals for the diversion of Forest Land for laying Optical Fiber Cable in 36 Forest Divisions of Telangana were submitted to the forest department. The Principal Chief Conservator of Forests, has communicated that "for proposals which are not passing through the existing Right of Way (RoW), including non-notified roads, the equivalent Non-Forest Land (NFL) needs to be identified and transferred to the State Forest Department for taking further necessary action".

In order to complete the T-Fiber project works within the targeted timelines, the transfer of NFL to the State Forest Dept. is considered as a critical activity, as it is interlinked with the release of permissions for project implementation from the Forest Department.

In this regard, you are requested to provide the details of land bank available across all Districts of Telangana, which could be transferred to the State Forest Department. This will help in issuing necessary instructions to respective District Collectors for further necessary actions.
