Sub: Approval of DPR for development of Angul-Balarampur-Jarpada rail corridor of M/s. Mahanadi Coal Railway Limited.
Ref: i) Railway Board's letter No: 2015/Infra/12/2 dated 27.10.2017.
ii) Your letter No: IRCON/2069/MCRL/ECOR/02/334, dated 21.12.2017.

Railway Board have accorded 'in-principle approval' to Angul-Balarampur-Jarpada rail corridor project vide letter under reference (i). After confirmation of traffic vide your letter No: IRCON/2069/MCRL/ECOR/02/338, dated 28.12.2017, Competent Authority has accorded approval to the Detailed Project Report. The Project shall be developed on the following lines:

1. Para 6.2 of Policy on 'Participative Model' issued by Railway Board vide letter No: 2011/Infra/12/32 dated 10.12.2012 with modifications, if any, from time to time shall be applicable.
2. Signing of Concession Agreement with East Coast Railway.
3. Surface connectivity at mid-section between Jarpada-Kerejanga for movement towards Angul station needs to be provided when mainline traffic level increases beyond 80% to avoid engine reversal.
4. All developments between DPR approval and commissioning of project shall be given as an addendum to DPR before opening of the project.
5. Payment of charges to the Railway as per extant rules.
