

 Your letter No: IRCON/2069/MCRL/ECoR/02/334, dated 21.12.2017.

Railway Board have accorded 'in-principle approval' to Angul-Balarampur-Jarpada rail corridor project vide letter under reference (i). After confirmation of traffic vide your letter No: IRCON/2069/MCRL/ECoR/02/338, dated 28.12.2017, Competent Authority has accorded approval to the Detailed Project Report. The Project shall be developed on the following lines:

- Para 6.2 of Policy on 'Participative Model' issued by Railway Board vide letter No: 2011/Infra/12/32 dated 10.12.2012 with modifications, if any, from time to time shall be applicable.
- 2. Signing of Concession Agreement with East Coast Railway.
- Surface connectivity at mid-section between Jarpada-Kerejanga for movement towards Angul station needs to be provided when mainline traffic level increases beyond 80% to avoid engine reversal.
- All developments between DPR approval and commissioning of project shall be given as an addendum to DPR before opening of the project.
- 5. Payment of charges to the Railway as per extant rules.
