### DETAILED NOTE ON THE PROJECT

The road of Dharmareddy to Muddapoor (via) Venkampally is identified as Rural road. This road crossed Manjeera river at km 5/4 near Venkampply village. At this location High level Bridge of 8v of 40m span is under construction. The proposed bridge is new river crossing and there is no existing nearby structure /Bridge on the river. This road forms approaches to the newly construction Bridge.

This road connects Kamareddy district with Medak District. By constructing the bridge and developing the apaches, there will be saving of 40km to reach Pappannapet mandal from Nagireddypet madal. Improvement of this road would improve further connectivity in terms of achieving smooth and safe traffic flow and improve level of service. In addition to above, substantial economic gain in terms of reduced Vehicle Operating Cost (VOC) and reduced travel time will be achieved.


This road is passing through the Reserve Forest from km 0/489.4 to 1/550. That is a length of 1060.6m with 20m width i.e. area of 2.121 Ha. The reach is located in Dharmareddy forest beat, Compartment No.695/RF Thandoor, Nagireddypet section & Range, in Kamareddy district Range.

The Government have accorded Administrative sanction for an amount of Rs.36.00 Crores vide G.O.RT No. 131 Dt:27.11.2014.

It is proposed to take up road construction along the existing single lane road in reserve forest area. As such the permission of the forest authorities is required. Hence proposal is submitted for diversion of forest land worked out to an extent of 2.121 hectares in Kamareddy division.
