Subsequent to the issue of Section-9 notification for private land of 2642 bigha for Mahi Banswara Rajasthan Atomic Power project (MBRAPP), consultation with PAPs and their core committee members (Adivasi Sangharsh Samiti) had been started by conducting various meetings. In parallel, social and economic survey of Project Affected Persons has also been started.


Though demand for more compensation is raised by the villagers based on discussion with villagers, it is likely that most of the villagers may agree for the compensation as per the enclosure .

You are requested to convey the approval of NPCIL for giving the compensation as per the enclosure which is in line with draft discussions of collector/SDM/LAO and PAP's and their committee.

Application for acquisition of Govt. land (87.23 Ha) and forest land (107.57 Ha) will be expedited once the award for acquisition of private land along with R&R package is declared.

As the award has to be made within 2 years of Section 6 dated 27-08-2013 we would appreciate a prompt response so that we can go ahead with acquisition process.


