ORDER:

In the reference 1st read above, the Engineer-in-Chief(Medium Irrigation) has submitted proposals for issue of No Objection Certificate in respect of M/s.Mohanroopa Power Projects Private Limited for establishing Mini Hydel Scheme of Capacity (3x4000 KW)=12.00 MW on Gomukhi River near Thonam Village, Salur Mandal, Vizianagaram District along with the recommendations of the Standing Committee meeting held on 15.04.2014, duly mentioning certain conditions therein, in addition to the General and Technical Conditions issued vide G.O.Ms.No.165, I&CAD(PW:Reforms)Deptt., dated:11.07.2007. Subsequently, the Chief Engineer, Hydrology vide reference 8th read above has submitted detailed report to the Government again, after placing the issue before the Standing Committee held on 15.04.2014 for issuance of 'No Objection Certificate'.

2. Government after careful examination of the proposal of the Engineer-in-Chief(Medium Irrigation) vide reference 1st read above and also Chief Engineer, Hydrology vide reference 8th read above, hereby issue “No Objection Certificate” to M/s.Mohanroopa Power Projects Private Limited for establishing Mini Hydel Scheme of Capacity (3x4000 KW)=12.00 MW on Gomukhi River near Thonam Village, Salur Mandal, Vizianagaram District, subject to the following conditions in addition to the General and Technical Conditions already issued in G.O.Ms.No.165, I&CAD(PW:Reforms) Deptt., dated:11.07.2007:-

- i) It is not the responsibility of the Government/I&CAD/NEDCAP/etc., for the economic viability and projected generation on power as shown in the DPR, which was submitted by the Developer in issuing of NOC of the proposed scheme.
- ii) I&CAD will not hold any responsibility for profit/Loss of the Project and assured sale of energy. In the above aspects the developer has to own up responsibility for any purpose whatsoever.
- iii) All the prevailing standards of Electricity Act and Rules & Regulations of the Government of A.P./Government of India issued from time to time shall be followed in various stages like finalization/selection of the equipment, etc.

P.T.O.,

- iv) Water availability is not the responsibility of Irrigation & CAD Department.
- v) All statutory clearances for the project, are to be obtained by the developer from the Government and on appropriate authorizations in respect of (i) Forest clearance (ii) Environment clearance (iii) and any other clearances necessary for the project from the competent authority duly following the procedures in vogue and the developer shall submit the same to the concerned Superintending Engineer, I&CAD Department before grounding the Scheme.
- vi) The Royalty charges or any other issues related to the payment to the Department will be as per Guidelines (or) Government orders issued from time to time.
- vii) Developers shall be encouraged to bring latest technology and maximize output subject to the Hydrological factors and environmental flow factors.
- viii) The Chief Engineer, Central Designs Organization shall ensure that designs approval are given in (15) days time failing which the developer will be permitted to go ahead for execution as deemed approval.
- ix) The royalty charges on water as applicable would be realized by the I&CAD on monthly basis.
- x) claims or damages shall lie with the Government for the cancellation/ suspension of N.O.C. for the reasons of River conservancy/floods management etc.
- xi) The Developer to commence the work within (6) months from the date of issue of N.O.C. and complete the Scheme within two years of N.O.C. failing which N.O.C. will be cancelled automatically.
3. The Engineer-in-Chief(Medium Irrigation), Hyderabad shall take necessary action accordingly.
