PNGRB, after examination of your request on the above subject has accepted the proposal/request to amend the authorization for the Geographical Area of Moradabad in favour of Torrent Gas Moradabad Limited (TGML) from the existing entity, Torrent Gas Private Limited (TGPL). TGPL was granted authorization for Moradabad GA through amendment issued on 13.06.2019 to the authorization, which was originally granted to Siti Energy Limited (SEL) vide letter no. S-Infra/II/1/2008-Vol.II/Moradabad-GA on 30.11.2012. Other terms and conditions, including work programme shall remain same as per authorisation letter dated 30.11.2012.

- 2. Further, TGML will be obliged to inform the Board in case any changes are made in the equity structure of TGML. Besides, TGML shall also abide by the existing/modified terms and conditions of the authorization including compliance with the service obligation and adherence to the quality of service standard.
- 3. TGML is accordingly permitted to take over the activities of laying, building, operating or expanding the CGD network of Moradabad Geographical Area.
