(iv)	Justification for locating the project in forest area	:	The Govt. vide GO Rt.No.218, Panchayat Raj and Rural Development (Progs.II) Dept, dated.03.04.2018 has approved administrative sanction for Construction and maintenance of roads and Bridges) PMGSY- Batch III scheme. The proposed project is one among them.  The existing road to a length of 4113.86 meters reach is passing through Gudem RF forest area of Kagaznagatr division. The existing road is very much essential and needs connectivity to Bejjur Mandal Headquarter enrouting number of interior villages, and also vehicular movement to the villagers and also for tranportation of goods.  As per the DGPS survey authentication report, the extent of area passing in the Reserve Forest area is 4.1139 Ha to a length of 4113.86 meters of width 10 meters.  As there is no alternative to that of for Construction of road, proposal is being furnished for diversion of forest land.
