NO.FRW-21/90/122,: In exercise of the Powers conferred by Section 18(1) of the Wild Life (Protection) Act, 1972, the Governor of Assam is pleased to declare the Dibru-Saikhowa Complex described in the Schedule below to be a Wild Life Sanctuary with effect from the date of publication of this Notification in the official Gazette.

B. Boundary Descriptions

Starting from O Mile post at Dholla Hatighuli
Dyke on the NH-37 (which can be located by running a line
at bearing of 230 38' for a distance of 1640 metres from
Railway Bridge on the Dholla river, to meet at Dholla
Hatighuli Dybe and thence measuring along the dyke at a
bearing of 1070 for a distance of 480 metres) along
NH-37 towards Saikhowaghat at a bearing of 160 for a
distance of 670 metres upto the left bank of Bandarkhal
nallah. Then along left bank of Bandarkhal up to the
confluence of Bandarkhal with the Lohit river.

North- From the confluence point of Bandarkhal with the Brahmaputra then towards West along the South bank of the Brahmaputra upto the old Laikaghat, thence along the South bank of the Brahmaputra towards downstream which is the original Dibru-reserve forests boundary upto the meeting point of Chabrujan.

West- From the juncture point of Chabrujan along downstream of the Brahmaputra upto the confluence of Dibru-river.

From the confluence of Dibru-river in the upstream along right bank upto the confluence of Chabrujan with Dibru-river (the Western end point of original Dibru river). Then runs upstream of Dibru river along right bank upto Khamtigowalighat (upto this point of Western part of the Dibru-Saikhowa Wildlife Sanctuary falls under jurisdiction of Dibrugarh Civil District) and then along the Southern boundary of the original Dibru reserve forests where it meets the Southern boundary of the Saikhowa reserve forests on zukha nallah. Thence along the Southern boundary of Saikhowa reserve forests towards east to a point near Hatighuli Beat. Thence along the Southern boundary of the Saikhowa reserve ferests towards east to a point at a bearing of 300 for a distance of 1,760 metres to meet the Dholla Hatighuli dyke. Then along the said dyke which runs at a bearing of 1210 for 420 metres 1220 for 280 metres 1170 for 920 metres 1000 for 1060 metres 145° for 1260 metres, 111° for 800 metres, 84° for 440 metres, 81 for 220 metres 900 for 300 metres, 930 for 100 metres, 52 for 400 metres, 69 for 700 metres, 93 for 80 metres, 106 for 140 metres 107 for 480 metres and meet the starting point.
