In this connection, it is intimated that the above said site has been inspected by the SDE P-II, along J.E. incharge of road. The land in question is away from PWD boundary. The processing fee in tune of Rs. 10,000/- has been got deposited by applicant vide Banker's Cheque No. 016062 dt.22.01.2021 on Rs. 5000/- & Rs. 5000 on dt. 9.3.2021. No Objection Certificate for construction of this shop/building is hereby granted with the following conditions:-

- 1- That no construction will be done within PWD land boundary. projection will be /That no Chajja projection and any encroachment/extended within PWD land boundry and if at any stage Chajja ed at the cost of the applicantis found on PWD land the same will be got remov
- 2- That thenatural porfile of the road land width will not be disturbed on account of this proposed .construction
- 3- That the construction should be at least 6 feet away from the PWD land boundary for parking, stair & projection etc.
- 4- There shall be adequate drainage systems on the access to the proposed structure and inside its area to ensure that surface water does not flow over the road.
- 5- There should be no inconvenience to the traffic with the construction of this proposed building.
- 6- There should be no violation of Scheduled Road Act if applicable.
- 7- That the applicant will construct the shop/building as per drawing.
- 8- The plan of the building will be checked / examined by the MC Kaithal/concerned authority as per Haryana Building Code 2016 & relevant act. During pre and post construction of the building, this office will not be responsible for any violation of norms of the Haryana building Code 2016 for construction of said building.
- 9- The permission of any other utility will be taken by the applicant from the concerned authority at his own level.
- 10- The client will be responsible to comply with above said conditions strictly, if any violation of the above said condition will be found on any construction or later stage, the NOC issued by this office may be treated as cancelled and stands withdrawn accordingly.
