

**BRIEF NOTE ON CONSTRUCTION OF HYDEL PROJECT AT

The Mini Hydel project with capacity of (3x4000 KW) 12.00 MW is proposed to construct on Gomukhi River near Thonam village, Saluru mandal, Vizianagaram District. An extent of 4.88 Ha of Forest land is required for the said project for M/s Mohanarupa Power Projects Private Limited, Vijayawada. The Hydel project is sanctioned by the Government of Andhra Pradesh in G.O.Ms.No.54, Irrigation & CAD (Reforms) Department, dated: 07.10.2014. It is a Hydel project intended to generate 12.00 M.W., Electricity by using Water from Gomukhi River, in Nanda Reserved Forest, near Thonam village, Saluru Mandal. The basic occupation of the people in this area is Agriculture and is totally rain fed and collection and selling of Forest produce. 
