This has reference to the above mentioned subject regarding the approval for laying 8" underground Steel Gas Pipeline from Km. 52+800 (Sanwali) to Km. 69+200 (Adhauli) Total Length 16.400KM along NH-91 (New NH-34) in the State of Uttar Pradesh.

In this regard, approval has been accorded by RO (Western-UP), Lucknow vide letter no. 19001/1/RO-W-UP/NH-91/Km. 52.800-69.200/8"Dia/466 dated 03.11.2020 with direction to follow the guidelines issued vide MoRTH circular dated RW/NH-33044//29/2015/S&R(R) dated 22.11.2016 & following condition:

The aforesaid NOC is being issued upon the successful realization of the requisite fee in "Bharat Kosh" as confirmed vide your letter dated 08.10.2020 & transaction ref. 0710200004335.

The crossing/laying will be done as per the proposed/agreed location (ii) route and as per proposed layout plan.

(iii) The M/s Indian Oil-Adani Gas Pvt. Ltd./ Licensee shall have to provide the safety measures like barricading danger lighting and other necessary caution boards while executing the work.

(iv) Appropriate fee be levied for use of NH land for laying of utilities as per MoRTH Circular no. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016

(V) Undertaking to the following effect is to be submitted by the M/s Indian Oil-Adani Gas Pvt. Ltd. and made part of the agreement:-

a. Three copies of "As Laid Drawings" of utilities (Hard and Soft copies) shall be submitted to Highway Authorities for verifications and record within a month of completion of works.

b. The permission may be terminated immediately on violation of the

agreed terms & conditions.

c. The execution of the proposal by the M/s Indian Oil-Adami Gas Pvt. Ltd. would not hinder the future widening, if any, at the particular location and if required then the applicant would ensure shifting of their utility at their own cost without any liability to NHAI in a time bound matter prescribed by NHAI.

e. The compliance of various undertakings given by the M/s Indian Oil-Adani Gas Pvt. Ltd. may be ensured before and after signing of License Agreement, as the case may be in the interest of safety of road users and NHAL

Laying/crossing work should be carried out through HDD method only. (vi)

It shall be the responsibility of the M/s Indian Oil-Adani Gas Pvt. Ltd. (vii) /Applicant to ensure the Safety and maneuverability of Highway Traffic during laying of Steel Gas Pipeline.

M/s Indian Oil-Adani Gas Pvt. Ltd. is responsible for the details provided (viii) in the application. The NHAI is at liberty to verify the authenticity of the documents at any time. Any misrepresentation, omission or suppression of facts or disclosure of incomplete facts detected at any stage shall lead to withdrawal of this approval with cost to the applicant.

In view of any future development requiring necessary alteration, (ix) including completion removal or shifting of the Steel Gas Pipeline, the same shall be carried out by the Applicant at its own cost to the

satisfaction the Highway Administrator.

In case of violation of the norms of Ministry's Guidelines, the NOC (X) automatically stand withdrawn.

IRC: 98-2011 be complied whichever applicable. (xi)

In view of above, you are requested to compliance of above mentioned 3. conditions alongwith an undertaking (mentioned at Sl. no. (v) & submit the fresh License Agreement (100/- Notarized stamp) as per MoRTH Circular no. RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016.

The work can be started only after the aforesaid agreement as per the Your's faithfully,
