2. You are directed to furnish the progress of Establishment of plant and machinery, green belt, Effluent Treatment Plant and Air pollution control devices, by 10th day of completion of subsequent quarter in the Board.
3. Copy of the work order/purchase order, regarding instruction and supply of proposed Effluent Treatment Plant/Sewerage Treatment Plant /Air Pollution control System shall be submitted by the industry till 31/12/2024 to the Board.
4. Industry will not start its operation, unless CTO is obtained under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and control of Pollution) Act, 1981 from the Board.
5. It is mandatory to submit Air and Water consent Application, complete in all respect, four months before start of operation, to the U.P. Pollution Control Board.
6. Legal action under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 may be initiated against the industry With out any prior information, in case of non compliance of above conditions.

1. This CTE is issued to M/S TORRENT GAS PVT LIMITED, to be established in Gate number - 1889, Village- Chaubeesi, Tehsil-Haidargarh, District- Barabanki (UP) as per the Land use submitted.
2. This CTE is valid for establishment of Natural gas (CH<sub>4</sub>) City Gate Station (CGS) of capacity 126 MT/Month.
3. The production capacity of the unit will be maintained as application form.. In case of expansion, it will be mandatory to obtain a No Objection Certificate from the Board.
4. Unit must obtain the NOCs from local body and Public Works Department before starting of work.
5. In the case of incident of accidental gas leakage by the unit, compliance with the instructions given by the fire fighting department should be ensured.
6. A warning board should be put in place by the unit at underground piping network site.
7. A separate cell should be set up by the unit for continuous monitoring of gas piping.
8. In the event of receiving public complaints and confirmation of air/water pollution against the unit, legal action will be taken after reviewing the consent.
9. The unit will follow the instructions mentioned in the Petroleum and Natural Exchange Board letter dated 29/03/2019.
10. Unit will send a copy of approved disaster Management route plan on the project by competent officer within a month.
11. This CTE is valid only for Domestic effluent discharge of 3.0 KLD through septic Tank/ Soak.
12. Unit should installed DG set of 62.5 KVA with canopy and stack height of 2.21 meter from above the ground level. It would be compulsory to take the no-objection certificate before installing the other D.G. set.
13. It is mandatory to obtaining a No Objection Certificate from the Fire Department.
14. Industry shall ensure to comply the norm's of Environmental (Protection) Act 1986.
15. Before commencement of production industry shall ensure to take valid Water/Air consent from UPPCB.
16. Industry shall ensure to comply the direction issued time to time by Honble's Supreme Court, Honble's High Court, Honble's NGT each.
17. Industry shall ensure to Comply the provisions of Plastic waste Management Rule 2016 as amended.
18. Industry shall ensure to comply the provisions of E-waste Management Rule 2016.
19. Industry shall ensure to comply the provisions of Batteries (Management and Handling Rule 2001 as amended.
20. Industry shall ensure to comply the provisions of Municipal solid waste Rule 2016.
21. The overall noise levels in and around area shall be kept well within the standards by providing noise control measures including acoustic hoods, silencers, enclosures etc, on all sources of noise generation. The ambient noise level shall confirm to the standards under the Environment (Protection) Act 1986.
22. Unit should make temporary storage facility for storage of hazardous waste in the premises before it will send to TSDF as per the provisions of Hazardous and Other Waste (Management and Transboundary Movement) Rules 2016
23. The industry should ensure to submit the land use certificate obtained from the competent authority within one month of issuance of this certificate, failing which the CTE would be void.
24. All safety measures should be installed as per energy response & disaster management plan submitted. Industry should comply the chemical accidents (emergency planning, preparedness' and response) rules 1996.

Please note that consent to Establish will be revoked, in case of, non compliance of any of the above mentioned conditions. Board reserves its right for amendment or cancellation of any of the conditions specified above. Industry is directed to submit its first compliance report regarding above mentioned specific and general conditions till 26/11/2020 in this office. Ensure to submit the regular compliance report otherwise this Consent to Establish will be revoked.
