Certificate of Non Availability of Alternate Land for CGD – Bhagalpur Project in Munger Division

Indian Oil Corporation is implementing City Gas Distribution (CGD) project in Lakhisarai, Munger and Bhagalpur Geographical Area.

The connectivity to feed Natural Gas to the CGD Bhagalpur Network is proposed from "Jagdishpur-Haldia-Bokaro-Dhamra Pipeline - (JHBDPL)" of M/s GAIL at its Terminal (Sectionalizing valve-08) at Village – Hathidah Buzurg (Thana no. 20), Mokamah, Distt.- Patna. CGD pipeline will feed the CNG outlets and PNG connection to demand centre in city/town of Lakhisarai and Munger. Therefore, Steel and MDPE Network is laid along major Roads utilizing minimum forest area in district of Lakhisarai and Munger.

It is hereby certified that there is no other alternate land available than proposed minimum forest land for laying/construction of CGD natural gas pipeline considering the connectivity between supply source and consumer location.
