## PREAMBLE:

The Managing Director Karnataka Renewable Energy Development Limited, Bangalore has recommended to allot 4.5 MW Wind Power Project at Kanchiganahal village in Madakaripura Wind Zone, Chitradurga District in favour of M/s. NEG Micon (I) Pvt. Limited.

This proposal has been examined in detail and decided to allot the capacity sought for. Hence, the following order:

# GOVERNMENT ORDER NO: DE 129 NCE 2002. BANGALORE, Dated: 31.5.2002.

In the circumstances explained in the preamble and after careful consideration of all the aspects of the matter, Government are pleased to allot 4.5 MW capacity Wind Power Project to M/s NEG Micon (I) Pvt. Limited at Kanchiganahal village in Madakaripura Wind Zone in Chitradurga District.

This order issues with the pending approval of the allotment committee and subject to the following conditions:

1. The company shall pay to Karnataka Renewable Energy Development Limited detailed project processing fee at Rs. 25,000. per MW before signing the agreement with Government of Karnataka

2. The company shall execute an agreement with the Government with in 3 months from the date of issue of the order allocating capacity failing which the allotment order shall be deemed to have automatically lapsed.

- 3. It shall be compulsory for the allottee to carry out site specific wind speed measurement at 10 meter and hub height levels for a minimum of one full wind year. The company shall prepare (in accordance with the guidelines issued by KREDL from time to time) and guidelines issued by KREDL from time to time) and submit (in 3 sets) a DPR containing details of micro siting done and submit the same to KREDL for approval. The company shall in corporate such modification in the design or layout of the wind farm as KREDL may recommend in order to ensure optimum generation safely or other technical requirements.
  - 4. The company shall install wind mast(s), at the rate of one mast for every wind farm of 5 MW capacity part thereof, as per the scale mentioned in the table given below to enable wind speed measurement at wind turbine hub height on a permanent basis to compare the actual performance of wind turbines installed in the farm in relation to the certified power curve of the WEG. The company shall furnish measurement data to KREDL.

6. The company shall obtain clearances from the Forest, Revenue and other relevant Government Departments where ever
