1. In reply to point No 1, it is submitted that, for making necessary correction under A-2 has been taken up with the NIC division of MoEF & CC, in this request a request has already been sent.
2. In reply to point No 2, it is submitted that, the necessary correction has been made under B - 2.2, B - 2.3 & B - 2.4 regarding total land in KML file.
