Through this office proceedings 1st cited, orders were issued permitting the Revenue Divisional Officer Yellareddy to hand over the Govt. land in Sy.No.258, Ext: Ac:2.30 gts PP land, Sy.No.263, ext: Ac 1.33 gts KK land and Sy.No.264 Ext: Ac 1-16 to a total Extent Ac 5.39 gts situated at Mengaram (V) of Lingampet (M) to Dist. Forest Officer Kamareddy under proper cover of panchanama, in lieu of diverted forest land in Sy.No.86 to an extent 2.121 Hector situated at Tandoor (V) of Nagireddypet (M) Yellareddy Division under Form-I Dt: 29.06.2018, for construction of High Level Bridge (HLB) across Manjeera river from Dharmareddy to Muddapoor via Venkampally road PR road.

2. Through the reference 2nd cited, the Dist. Forest Officer Kamareddy has informed that, the above said land falls under Reserve Forest Block of Bollaram Section of Yellareddy Range and requested to identify non – forest land suitable for Compensatory Afforestation out side the Reserve Forest.

Accordingly, the Revenue Divisional Officer, Kamareddy who was requested to identify suitable Govt. land for the abov said purpose has submitted a proposal through ref 3rd cited stating that, the Tahsildar Rajampet along with Forest officials have conducted joint inspection and have identified a Govt. land (Cherai) in Sy.No: 131 to an Extent of Ac. 6.00 Gts situated at Argonda (V) of

Rajampet (M) Kamareddy Division which is suitable for compensatory afforestation, in lieu of diverted forest land in Sy.No.86 to an extent 2.121 Hector situated at Tandoor (V) of Nagireddypet (M) Yellareddy Division under Form-I Dt: 29.06.2018, for construction of High Level Bridge (HLB) across Manjeera river from Dharmareddy to Muddapoor via Venkampally road PR road.
