This non-forest land is adjacent and western side to the already identified non-forest land over an extent of 4.776 ha for C.A in lieu of diversion of 4.73 ha in favour of EE, MI (W) Division, Kurnool. The C.A land falls in Owk Beat, Banaganapalli Section of Dhone Range of Kurnool Division.
