M/s Friend Filling Station was being operated as a B Site Retail outlet under SC Category at Kartarpur District Jalandhar since 31.05.1987. The land on which the petrol pump was located was taken on lease by dealer for 25 years which expired on 13.11.2011. Subsequently landowner approached us for vacating the land. Meanwhile NOC issued by DC, Jalandhar was cancelled vide letter dated 03.07.20212 and also explosive licence was cancelled by Explosive Deptt. On 01.08.2012.

As per guidelines from Ministry of Petroleum, this retail outlet is eligible for resitment of petrol pump. Accordingly LOI holder, Sh. Satnam Singh S/o Sh. Kartar Singh has offered land at Khasra No 53//15, 53//16/1/1 at Village Alawalpur on Adampur-Alawalpur Road, District Jalandhar.

We propose to set up a MS / HSD Regular Retail Outlet at location "Village Alawalpur on Adampur-Alawalpur Road, District Jalandhar, Punjab" to cater Petrol and Diesel to the local public and vehicles passing through the vicinity at large on the plot admeasuring 31 mtrs (front) X 36 mtrs (depth) and as per attached layout, bearing details as below:
