In the reference 1st cited, It is informed that the Regional Empowered Committee has given following instructions during the field inspection on 13.12.2022.

- 1. The 16 nos marked for felling need not to be felled if road carriage way with 3.75 m tarring can be made and requested that the proposal may be revised accordingly.
- 2. To provide mitigation measures for the safety of animals crossing the roads in the proposed tract lies in the reserved forest.

I wish to submit that as per the instructions, the alignment of the road has been revised to length of 5.173 km and width of 6.00 m and area of the diversion of reserve forest land is 4.00 ha. The KML of the road alignment of 4.00 Ha and KML of Compensatory Afforestaion land with an extent of 8.00 Ha has been revised and updated in webportal and it is informed that following particulars are not able to edit in FORM-A of parivesh portal.

The land identified for Compensatory afforestation by this office in SF.No. 692/7 of No.18 Kammapatty Village. Nallampalli Taluk. But during the REC Committee inspection on 13.12.2022, it is informed that the identified land has already a good growth of vegetation and also the forest department suggested the Thoppur Reserved Forest for raising compensatory afforestation over 8.00 Ha. Hence, user agency will pay the entire cost of compensatory afforestation which to be done in Thoppur RF for the Forest land (Pallipatti RF,Thomabakkal RF and Thomabakkal Extension RF) diverted for the above said road. All the additional details are updated in parivesh portal.

I wish to invite to the ref 2nd cited, wherein the undertakings of change in alignment not affecting the 16 nos of trees and to provide necessary mitigation measures on the proposed tract by the user agency own cost.

Hence, it is requested to consider diversion of 4.00 ha of forest land in Pallipatti RF, Thomabakkal RF and Thomabakkal Extension RF for formation of road from Vachathi to Kalaspadi Road via Arasanatham and Poigoundanvalasu tribal habitations of Sitheri Panchayat in Pappiredipatty Block.
