Along road from Kheerwara-Ratanpur G J border via Channi,  
Kanbai, Boslathi, Talaiyan =45.00 KM

You are requested to please furnish the restoration cost estimate of the CC/BT/WBM road portion likely to be cut/ damaged along the proposed route, subsequent to the permission from this office to be issued.

2. While preparing Restoration Estimate for WBM/ BT Road cuts, it should be kept in mind that the OFC cable is to be laid at the extreme end of road width, and not along the BT pavement.
3. Please furnish the estimate along with verification of route length submitted by the applicant in key plan within 10 days.
4. If the jurisdiction of the route under consideration is with the UITs/ Municipal Councils, the restoration cost estimates is to be arranged, by you and submitted to this office within the above scheduled period.
5. If no information/ estimate is received within 10 days, it will be presumed that no restoration is involved, and no charges are to be claimed from the Entrepreneur.
6. You are also directed to insure that no work will be executed on this road, before the written permission, issued from this office.
