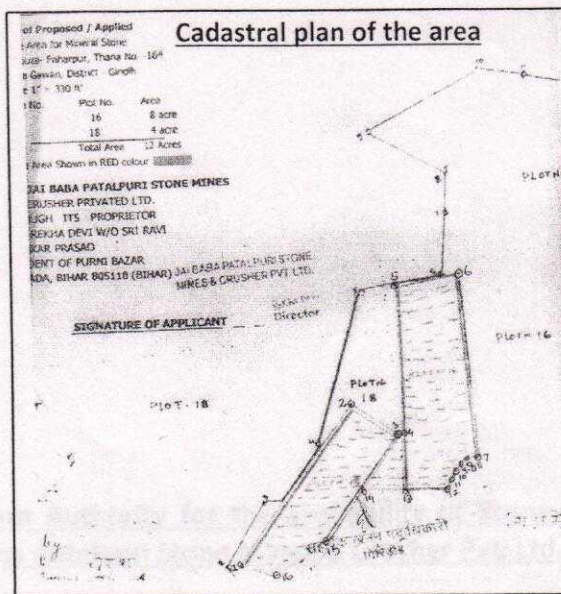


## Inspection Report of Paharpur-Mauza, Gawan-Block, Giridih-District

In compliance of letter no. 1656 dated 06.12.2017 of Director, Geology an inspection of the area Mauza-Paharpur, Gawan Block, Giridih District was carried out on 12.12.2017.

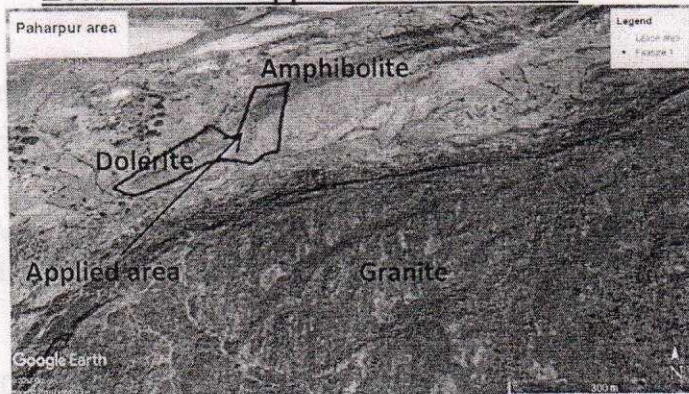
**Location and Accessibility:** The area is approachable from Tisri by metalled road which is about 15 Km from Tisri on Tisri-Gawan road. After reaching Harhara the area can be reached by unmetalled road in south direction by travelling about 1.5 Km. This area falls under toposheet no. 72H/14 and the bounding co-ordinates of the area are as follows:-

**Observation:** The investigated area is a part of Bihar Mica Belt. The area comprises of mainly three lithounits. The south-western portion of the area consists of a dyke body of dolerite. The dolerite dyke body has a general trend of N40°E and the approximate dimension is 300mX100m. In the central portion of the area around 24°35'44.80"N, 85°57'29.94"E a quartz rich pegmatitic body is also observed. In the northern portion of the area amphibolite is exposed in the area. Distance from Sakri river from the applied area is less than 500m. Sewadhab protected forest is situated in the East and South East of the area. The highest hill which is located inside Sewadhab PF is Kala Pahar (383 meter). It is mainly composed of granite and granite gneiss which is extended over a large area. The location of applied area and adjacent hill of granite can be seen in satellite imagery given below:-

## NOTE CONTAINING JUSTIFICATION FOR LOCATING THE PROJECT IN FOREST AREA

**Applicant:** M/S Jai Baba Patalpuri Stone Mines & Crusher (Pvt.) Limited

**Village :** Paharpur, **Anchal :** Gawan, **Thana:** Gawan, **Dist.:** Giridih, Jharkhand in

### **JUSTIFICATIONS:**

1. The Lease area contains the Stone (Granite and Granite Gneisses), which is suitable for the use as Building Stones and Ballast Stone for Railways.
2. The quality of the Stone has been assessed by the RQP as one of the best rocks to be used for such purposes.
3. The total Geological Reserve has been estimated as 2384503.54 metric tonnes and the total Mineable Reserve has been estimated as 2104190.02 metric tonnes.
4. The Reserve is Site Specific and the same quality as well as the quantity is not available in nearby non forest area. Hence it cannot be shifted to any alternative location.

Dear Sir,

The followings are the pointwise justifications on the query as raised:

- a) It may be noted that the entire Jharkhand State is affected by the poverty, unemployment, naxalism etc. in which the Giridih district is badly suffering from all these problems in spite of the natural resources available in the district.
- b) The Illegal Mining is widely reported from the area even from the forest area.
- c) The Mining activities of the area shall not only stop the illegal mining but also the naxal activities shall be minimized by providing employment to the local people.
- d) The MMRD Act clearly states that the Mining activity is site specific activity and it can be performed only at the places where the particular mineral is available.
- e) As per the approved Mine Plan, 2384503.54 Tonnes of stone is available in the applied area which coincidentally lies in the Forest area. That is the reason for selecting the area for mining.
- f) It will be unjustified and improper to mention that the Granite and Gneiss are available only in the applied area because these stones are available in other parts of Giridih district also.
- g) But during the course of exploration for this mineral in Gawan , Tisri, Sariya and other places, it was observed that such deposits are either already allocated to other Applicants or these cannot be mined on the ground of Environmental Clearances or these are located near to habitation/ Educational Institutes / Hospitals / Rivers/ other water bodies etc. Even if I apply for

these deposits, it will be very difficult to get the Environmental Clearance by DEIAA as these will be within the environmental sensitive areas as defined by MOEF.

- h) But due to the location and availability of stones in good quantity, the above mentioned site has been selected for the development of Infrastructure including the road, rail buildings etc.
- i) In view of the above mentioned facts, it is very clear that I have no other option to apply other than this area because of the location. Geological Reserve, availability of labour, infrastructure etc.

Keeping in view of the above facts and my interest to development of the state by providing the employment to poor people of the area, the necessary approval on my proposal of Forest diversion may be accorded. I shall be oblige for your kindness.
