Please refer to the Integrated Regional Officer letter No. 8B/HP/01/18/2021/FC/, dated 14.09.2022, in which he said that they have re-analyzed the proposed Hydro Power project on the latest digital boundaries and found variation in aerial distance. Therefore, he has asked the state government to clarify the position by presenting a detailed comment regarding the variation in aerial distance.

In this context, the DFO Wildlife Kullu has sent us a letter regarding the Aerial distance of our project from the Nargu Wildlife Sanctuary and its ESZ which we have uploaded in the other information details.

Apart from this, the said proposal was also rechecked by the Integrated Regional Officer as per the instruction of the Ministry of Environment, Forest and Climate Change office and some shortcomings were also found. In this regard we are submitting point- wise reply for your kind consideration as under;

1. In reply to the point no. 1, the detailed list of approved /existing/ proposed projects in the river basin area /landscape showing Evacuation /Transmission Plan of each project along with their impacts have been prepared and uploaded in the other information details. .
2. In reply to the point No. 2, we have prepared the KML file and a Geo-referenced map showing boundaries of nearest (PA) and its Eco- Sensitive Zone and the distance of each Hydro Electric Project from nearest PAs and their ESZs and uploaded again.
3. In reply to the point no. 3, a letter from Superintending Engineer office (DOE) to the Nodal officer cum CCF (FCA) HP for the detail regarding total carrying capacity of river/ rivulet have been uploaded in the other information details.
