The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conervation) Act. 1980, subject the following conditions:

- 1. The permissions is granted only for the use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.

  The forest land shall not be used for any purpose at the state of the purpose.
- The forest land shall not be used for any purpose other than that specified in the FCA proposal.
- The User Agency will have to obtain permission from this office for carrying out any maintenance works in future.
- The User Agency will have to make good the forest land after use/maintenance work. No tree shall be cut.
- The User Agency will be liable to make good any loss to Forests/Environment caused due to the use of tha said land by the user agency.

The user agency will seek permission from the Roads & Building Department/Science and Technology Deaprtment, Sachiyalaya, Gandhinagar.

The OFC will be laid underground in a trench of depth of 1.65 meter and width of 0.45 meter in between rows of road side plantation.

Any other condition, which the Nodal Officer (FGA) may stipulate from time to time.
