The proposal submitted by the user agency for construction of railway siding under Forest (Conservation) Act 1980 has been examined and found to be complete in all respects. Thereafter the proposed site has also been inspected and visited and it has been found that the proposed site is really required by the user agency for transportation of coal from the present Amrapali OCP and the upcoming OCPs of Amrapali and Chandragupta. The instant proposal of rail mode coal transportation is also less damaging to the forests and environment in comparison to the coal transportation through road mode and therefore taking into all the aforesaid facts and consideration, the instant proposal for the construction of railway siding is recommended under the provisions of Forest (Conservation) Act 1980.
