**Subject: - Acceptance of Central Government Authorization to M/s Green Gas Limited (M/s GGL)
for Agra CGD Network**

Sir,

This has reference to our letter No: PNGRB/08 Dated 22.10.08 and all other correspondence on this subject including your letter No: GGL/F&A/BG/PNGRB/2009-10/1638 Dated 03.11.2009 wherein you have submitted Performance Bank Guarantee for Agra CGD Network vide BG No : 0505909BG0000162 Dated 03.11.2009 for an amount Rs 6,00,00,000/- (Rupees Six Crores).

The Petroleum & Natural Gas Regulatory Board in view of the authorization given by the Central Government vide letter Ref: 16019/07/08-GP dated August 25th, 2008, hereby grants exclusivity for 5 years from the date of issue of Performance Bank Guarantee to M/s Green Gas Limited for Agra CGD Network as requested by GGL vide letter No: GGL/MD/PNGRB/2009/802 Dated 29.05.2009, subject to the terms and conditions mentioned below:

- 1) M/s GGL shall abide by the provisions of the PNGRB Act, 2006 and relevant regulations including amendments thereof, if any, framed from time to time.
- 2) M/s GGL shall abide by the Technical Standards and specifications including Safety Standards (T4S) for, city and/or Local Natural Gas Distribution Networks Regulations 2008 including the Emergency Response & Disaster Management Plan (ERDMP).
- 3) The GGL shall abide to Quality of Service standards as per regulations framed under PNGRB Act, 2006.
- 4) M/s GGL shall abide by the regulations covering exclusivity for marketing of gas from the purview of Contract Carrier & Common Carrier as specified in the Petroleum and Natural Gas Regulatory Board (Exclusivity for City or Local Natural Gas Distribution Network) Regulation, 2008
- 5) The Geographical Area & Charge Area accepted for CGD Network Authorization for Agra GA is as per submitted map duly signed by M/s GGL & PNGRB (Copy enclosed). The project milestones for the above CGD Network development shall be as per Annex-1.

Violation of any condition/conditions mentioned in clauses 1 to 5 shall be treated as default and shall be dealt as per the provisions of the PNGRB Act, 2006.

M/s GGL shall submit the Network Tariff and Compression Charge for CNG as per the Petroleum & Natural Gas Regulatory Board (Determination of Network Tariff for City or Local Natural Gas Distribution Networks and Compression Charge for CNG) Regulations, 2008 for the approval of the Board separately within 30 days of the issue of this letter.




