Sub.: NOC for Overhead Crossing of NH-91 by 765 KV S/C Mainpuri - Unnao EHV Transmission Line at Km. 383.000 in the State of Uttar Pradesh.

Sir,

This has the reference to your letter no. SEUPPTCL/NHAI/2015-16 dated 02.03.2016 vide which you have applied for the permission of overhead crossing of NH-91 by 765 KV S/C Mainpuri – Unnao EHV Transmission line at Uttaripura, Kanpur.

The Competent Authority NHAI has accorded in-principal approval for the above proposal subject to the following conditions.

(i)

- (a) To pay necessary fee for the use of NH land whenever fee is asked by highway authority in future.
- (b) To relocate overhead line at their own cost notwithstanding the permission granted within such time as well be stipulated by NHAI for future six laning or other development.
- (c) Certificate that no other structure will be erected nor other service rendered within the ROW of NH without prior permission of NHAI.
- (d) SEUPPTCL, Lucknow will own responsibility for any mis-happening during executing of work at site/crossing.
- (e) Undertaking for necessary alteration including complete removal/shifting of Transmission line Tower at their own cost, if so required by the NHAI/Ministry, for the development of NH or in the interest of safety in the above section.
- (f) If any deviation is found at any state in compliance to the agreed terms & conditions, the NOC granted shall be treated as null and void.
- (g) SEUPPTCL, Lucknow be responsible for all kinds liabilities arise during or after execution of work.

- (h) The applicant shall shift/modify on its own cost within a prescribed time period fixed by NHAI in case of widening/construction of elevated structure at the location, or any other requirement.
- (i) Before start of work at site, the permission agreement (copy enclosed) may be executed with the agency and ensure completion of work in agreed time limit for which work programme may be obtained and approved.
- (j) The work should be executed under supervision of NHAI.
- (k) Prevalent license agreement should be execute with PD, PIU-Aligarh.
- (l) The Licensee shall have to provide the safety measures like barricading danger lighting and other necessary caution board while executing the work.
- (m) Grant of license is subject to the licensee satisfying (a) minimum disruption of traffic and (b) no damage to the highways.

You are requested to ensure compliance of all the above mention conditions with early submission of required undertakings to issue the proper crossing permission from this office.
