

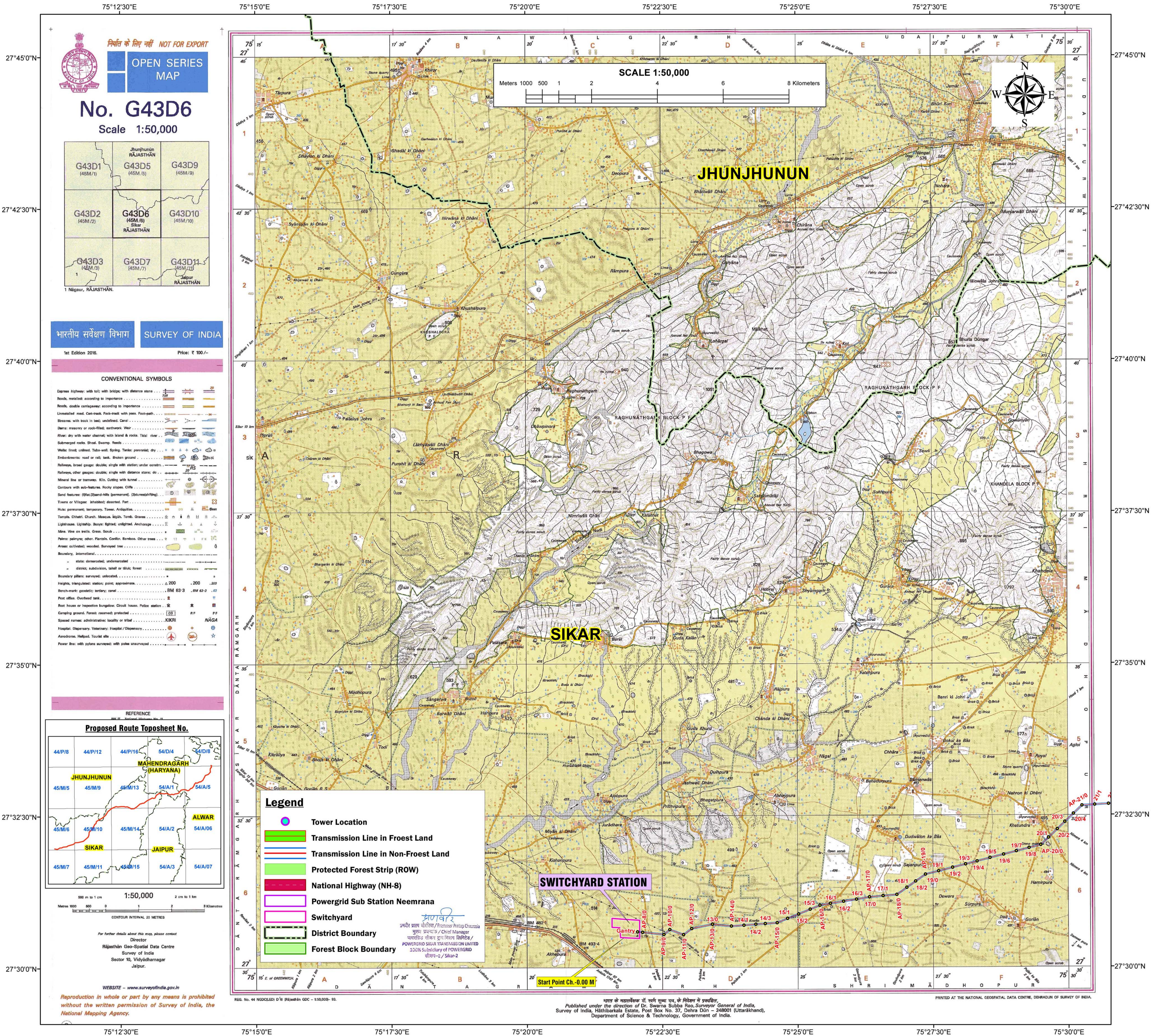
MAP SHOWING GEO-REFERENCE SURVEY OF INDIA TOPOSHEET WITH

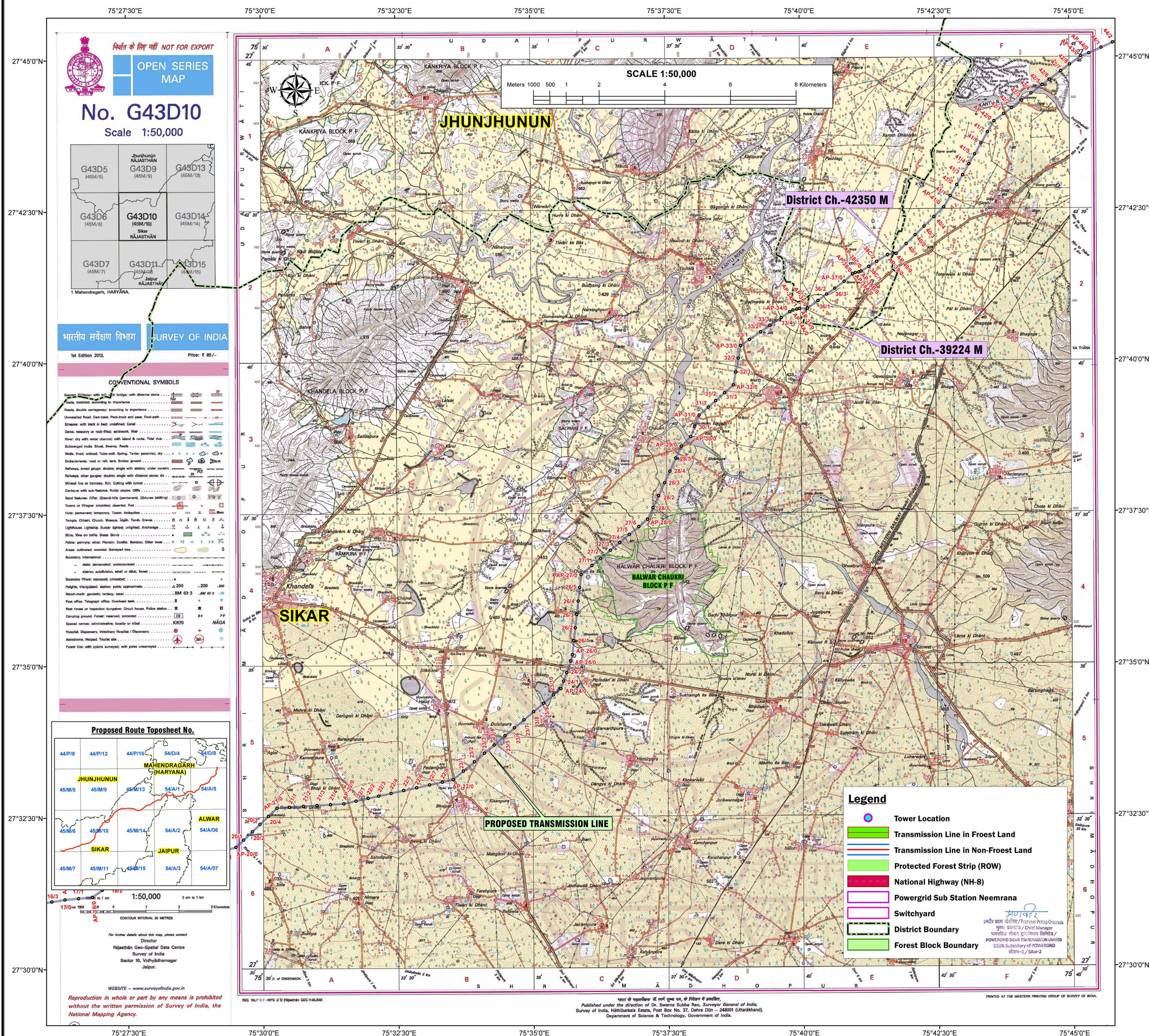
MAP SHOWING GEO-REFERENCE SURVEY OF INDIA TOPOSHEET WITH

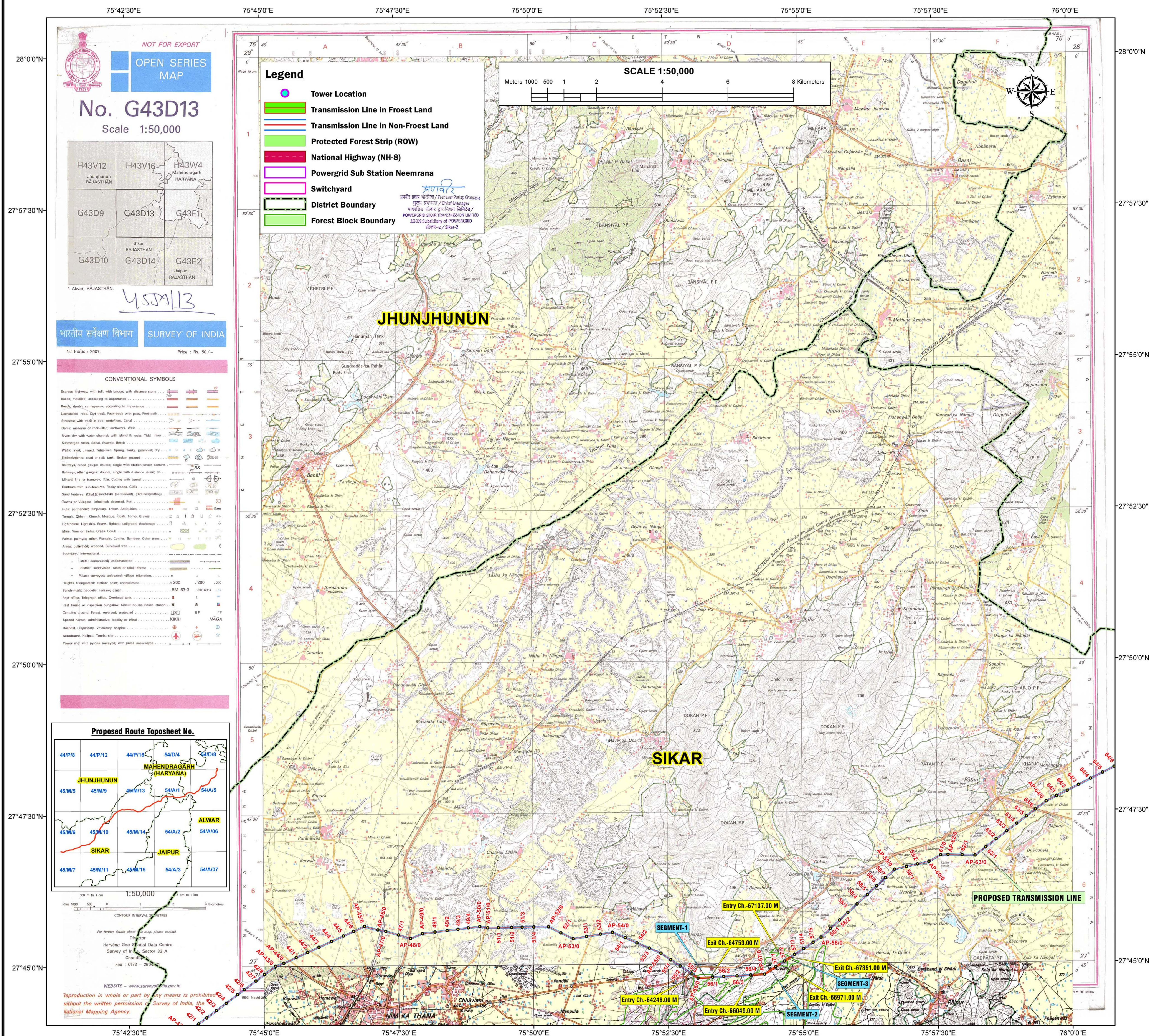
MAP SHOWING GEO-REFERENCE SURVEY OF INDIA TOPOSHEET WITH

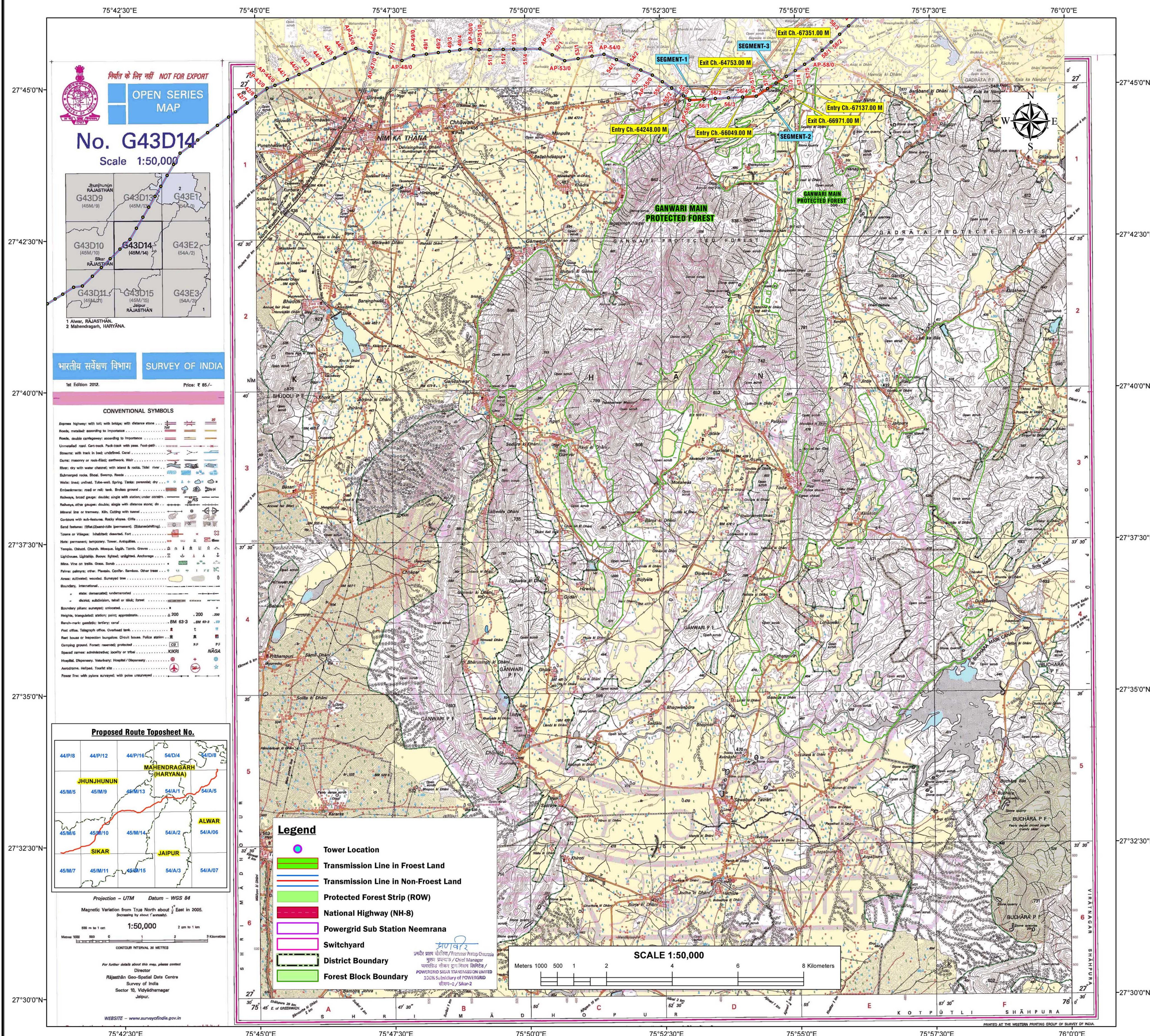
