(i) Short narrative of the proposal and project /scheme for which the forest land is required	The proposal involves construction of Sewerage Treatment Plant at Chimbahar in Mohal Chimbahar, Tehsil Palampur, District Kangra H.P. The proposal requires 0.2094 hectare of forest land for construction of Sewerage Treatment Plant and Dumping Site. Due to the increasing population of nearby areas and growing problem of disposal of sewerage waste there is an immense need of this plant which has been proposed near Palampur city.
(ii) Map showing the required forest land, boundary of adjoining forest on a 1:50,000 scale map.	Layout Plan of the proposed area marked in relevant part of the SOI Topo Sheet is attached herewith - Scale 1: 50,000.
(iii) Cost of the project:	Rs. 50 Lacs.
(iv) Justification for locating the project in forest area.	The proposal needs an area of 0.2094 hectare and there is no suitable Non Forest land available in the surrounding area. There is no Private / Govt. Land comes in the proposed alignment, therefore all components have been conceived in the forest land. Moreover the

	Sewerage Treatment Plant is to be proposed far away from the residential / commercial area, so this barren land has been selected for the purpose.

(vi) Employment likely to be generated.	7500 mandays shall be generated during construction and 2 persons shall be engaged for effective running and maintenance of the Sewerage Treatment Plant.
