In inviting a reference to the aforesaid memo on the captioned subject, on scrutiny of the above diversion proposal submitted by you the following discrepancies have been noticed-

- 1. The forest diversion proposal has been submitted for diversion of 32.225 ha forest land(Fresh diversion-17.795ha+ rediversion-14.43ha) for rehabilitation and up-gradation to four laning of 7.6 Km stretch (Km 229.00 to Km 236.600) inside buffer zone of Similipal Tiger Reserve of NH-6 but in Part-II and Part-III, the area mentioned is 17.795 ha only.
- 2. Being a linear project, you have not furnished the existing width of the road and width to be maintained after rehabilitation and up-gradation of the entire ghat road over 7.600 Km.
- 3. The GPS co-ordinates of the start point and the end point of the ghat road to be rehabilitated and upgraded under Bisoi Range of Rairangpur Forest Division are to be furnished.
- 4. Undertaking for payment of NPV by the user agency has not been furnished.
- 5. CA Scheme:-

a)The details of non forest/degraded forest land identified for raising of Compensatory afforestation, DGPS surveyed sketch map showing Area, Pillar No, Coordinates, Forward and backward bearing and pillar to pillar distance etc. authenticated by the ORSAC and countersigned by the DFO and Tahasildar concerned has not been furnished.



Sir,

In inviting a kind reference to the subject cited above, it is to submit that Stage-II Clearance of 4-laning of Baharagora to Singhara Section (Km 199.200 to Km 310.806) of NH-6 (Length - 111.606 Km) was obtained vide MoEFCC letter dated 8<sup>th</sup> December, 2020 but widening in the 7.6 km stretch (Km 229.00 to Km 236.600) passing through buffer zone of Simlipal Tiger Reserve was not recommended by NBWL. Hence, the forest clearance for 4 laning was accorded for only 67.309 ha. land (instead of 85.104 ha. applied for entire package).

Considering the criticality of this 7.6 km. stretch on safety aspects, NHAI decided to again resubmit the case for 4 laning of this 7.6 km stretch and obtain requisite approval under FCA. The proposal was initially uploaded for the entire forest land of 32.225 ha involved in the 7.6 km stretch but later on it was clarified that 14.43 ha. was already accorded Stage-II forest clearance on 08.12.2020 which was part of 67.309 ha. as mentioned above. The current proposal involves diversion of the remaining 17.795 ha. forest land as mentioned in the table below:


