Diversion of 4.00 hat of forest land in F.Sy.No.93 of Yamunapur Village (Basavankoll Hillock), Belgaum Forest Division, Belgaum District for construction of Water Treatment Plant and allied works in favour of the Commissioner, City Corporation, Belgaum-Reg.

Please refer to the State Government's letter No.FEE 06 FLL 2013 dated 26/02/2013 seeking prior approval of the Central Government in accordance with Section 2 of Forest (Conservation) Act, 1980 for the above mentioned project.

After careful consideration of the proposal, I am directed to convey Central Government's approval in-principle (Stage-I) under Section'2 of Forest (Conservation) Act, 1980 for diversion of 3.35 ha. (excluding area proposed for staff quarters and area proposed for future expansion) of forest land in F.Sy.No.93 of Yamunapur Village (Basavankoll Hillock), Belgaum Forest Division, Belgaum District for construction of Water Treatment Plant and allied works in favour of the Commissioner, City Corporation, Belgaum, for a period of 20 years, subject to the following conditions:

- The legal status of forest land shall remain unchanged
- Demarcation of the proposed forest area shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 mts, at the cost of User Agency.
- The equivalent identified non-forest land in Sy.No.124 of Ashte Village in Belgaum Taluk proposed for Compensatory Afforestation shall be transferred and mutated in favour of State Forest Department.
- 4. The cost of raising Compensatory Afforestation over the identified non-forest land shall be deposited by User Agency.
- Cost of raising plantation over 25 ha, around the proposed area shall be realised from User Agency to prevent soil erosion.

- 6. State Government shall charge the Net Present Value of the diverted forest land measuring 3.35 ha, from User Agency as per the orders of the Honble Supreme Court dated 28.03.2008 and 09.05.2008 in IA Nos 826 in 566 with related IA's in Writ Petition (Civil) No.202/1995.
- 7. Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by State Government from User Agency. User Agency shall furnish an undertaking to this effect.
- 8. The funds received from User Agency towards Compensatory Afforestation and Net Present Value under this project shall be deposited either in SB A/c No.SB01025213 CAF Kamataka, Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110003 (RTGS/IFSC No.CORP0000371) or in SB A/c No.344902010105 421 KARNATAKA CAMPA, Union Bank of India, Sundar Nagar, New Delhi-110003 (RTGS/IFSC No.UBIN0534498). The details of deposition of funds including, inter-ella the DD Numbers & date. Amount, the Bank on which drawn and the date of deposition in the designated Bank shall also be furnished.
- Construction of residential quarters/staff quarters shall not be taken up in the proposed area. User Agency shall furnish an undertaking to this effect.
- 10. User Agency shall pay cost for construction of retaining wall all around the project site as well as construction of Check Dams and other SMC works wherever required to control sliding of soil and erosion into the Markandeya River which is flowing nearby at a distance of about 2 Kms; as per the plan prepared by the Deputy Conservator of Forests.
- 11. The total forest area utilized for the project shall not exceed 3.35 ha
- 12. Any other condition that the Additional Principal Chief Conservator of Forests (Central), Regional Office, Bangalore may impose from time to time for protection, improvement of flora and fauna in the forest area and public convenience, shall also be applicable.

After receipt of the compliance report on conditions No.(2) to (10), the proposal will be considered for final approval. Transfer of forest land to User Agency shall not be effected prior to the issue of final approval. This in-principle approval shall be valid for a period of 5 years. In the event of non-compliance of the stipulated conditions, this in-principle approval shall automatically stand revoked after 5 years.

And whereas the Lessor by G.O.No. FEE 06 FLL 2013 Bangalore dated: 13-10-2014 has agreed to let out to the Lessee an area of 3.35 ha. of Forest land in Forest Survey No. 93 of Yamanapur village of Belgaum Taluk for the purpose of construction of Water Treatment Plant and allied works and the Lessee has agreed to take on Lease the scheduled Land on the terms and conditions hereinafter contained namely:-

- 1 The legal status of Forest land shall remain unchanged and it shall continue to be forest land
- 2 The lessee shall pay lease rent as fixed by the Government from time to time
- 3 The lease tenure is for period of 20 (twenty) years
- The leased out area should be used for the purpose for which it is granted. In case the land or any portion thereof is not used for the stipulated purpose within two years, the area should be resumed to the Forest Department under Section 82 of Karnataka Forest to 1963. The concerned Deputy Conservator of Forests is authorized to take necessary aption in this regard.
- 5 No structures /residential buildings shall be permitted in the proposed forest are
- The Karnataka Forest Act 1963 and Rules 1969 and other relevant Acts & Rules will be applicable for any violation.
- The site proposed for diversion is situated on the hillock and the area surrounding the project site is having steep slopes, giving scope for soil erosion. To contain this at least 25.00 ha, plantation around the proposed area to be carried by Karnataka To Department at the cost of the User Agency at the rate of prevailing compensation.
- 8 The User Agency shall pay the cost of raising compensatory Afforestation at the rate prevailing at the time of sanction. (At present it is Rs. 1,52,000/- per ha.)
- 9 The User Agency has to pay the Net Present value (NPV) of forest land diverted under this proposal as per Orders dated: 28-03-2008 and 09-05-2008 of the Hon'ble Supreme Court of india and undertaking for additional amount of the Net Present Value if any.
- 10 The User Agency shall ensure that there shall be no damage to the available fauna and flora
- 11 No labour camp shall be established on the forest land
- 12 No work shall be allowed after sunset.
- The User Agency should pay cost for construction of retaining wall all around the project site as well as construction of Check Dams and other SMC works whereever required to control sliding of soil and erosion in to the Markandeya River which is flowing nearby at a distance of about 2 Kms as per the plan prepared by the Deputy Conservator of Forests.
- 14 No alteration shall be made to the project plan including adding any structures/buildings without prior approval of the Forest Department.
- Any damage to the adjoining forest area due to the project works shall be compensated by the User Agency. The extent of damage shall be assessed by the concerned Deputy Conservator of Forests.

The Term "Governor" shall be deemed to mean the Governor of Karnataka his successors and assigns

The term " the Lessee" shall mean The Commissioner, City Corporation, Belagavi and officer authorized in writing by its management
