Sub: Allotment of Govt. lands in lieu of diverted Forest lands – Kamareddy District – Diversion of forest lands to an extent of 14.450 Ha for various Govt. projects in the district- Identification of Ac. 38.11 ½ Gts Govt. land (non forest) in Sy.No: 316/1 situated at Konapur (V) of Bibipet (M) – Permission accorded to hand over the identified subject land in favour of forest department duly cancelling the orders on allotment of Ac. 13.00 Gts of Govt. land in Sy. No: 42 situated at Kalwaral (V) of Sadhashivnagar (M) – Orders issued- Reg.

ORDER :

Through the ref. 1st cited, the Executive Engineer (R&B) Division Kamareddy has requested to arrange for allotment of 4.7231 Ha of non forest land for compensatory afforestation as requested by the Pr. Chief Conservator of Forest, Telangana State, Hyderabad in lieu of said forest lands diverted for improvement works to widen Banswada – Uppalwai road from Km 17 / 080 to 18 / 278 & 22 / 180 to 23 / 042 in single lane BT Road, passing through the limits of Pothangal Kalan (V) and Medipalli (V) Grampanchayath jurisdiction of Gandhari Mandal of Kamareddy District.

Accordingly, duly following the procedure, Form –I Dt:23.11.2019 was issued by this office for diversion of 4.7231 Ha of forest land for above said purpose and in lieu of diverted forest land and through this office letter the Revenue Divisional Officers in the district were requested to identify non forest Govt. land suitable for compensatory afforestation in lieu of diverted forest land for the above said purpose. Similarly, forest land was also diverted for other Govt. works duly issuing Form-I certificates under RoFR Act 2006. The total forest land diverted in the district is 14.450 Ha i.e., Ac. 38.11 ½ Gts.

Through the ref. 3rd cited, the Revenue Divisional Officer, Kamareddy has reported that, the Tahsildar, Sadhashivnagar along with Forest Range Officer, Kamareddy have identified Govt. land to an extent of 13.00 Gts in Sy No: 42 situated at Kalwaral (V) of Sadhashivnagar (M) which is free from

encroachment and suitable for compensatory afforestation and accordingly vide this office proceedings 4th cited, orders were issued for allotment of the said land in favour of forest department in lieu of diverted forest land for the purpose narrated at para (1).

While matter stood thus, during the meeting held with RDO, Kamareddy, Tahsildar, Sadhashivnagar, Dist. Forest Officer, Kamareddy and Forest Range Officer, Sadhashivnagar, the District Forest Officer, Kamareddy has informed that, the land in Sy No: 42 Ext: Ac. 13.00 Gts situated at Kalwaral (V) of Sadhashivnagar proposed to handover to forest department belongs to forest department and requested to allot another suitable Govt. land. Accordingly the RDO, Kamareddy and DFO, Kamareddy were directed to conduct joint survey of Sy No: 42 of Kalwara (V) of Sadhashivnagar (M) and also directed to the RDO, Kamareddy to identify the Govt. land suitable for compensatory afforestation for entire projects in the district where forest lands were diverted and also directed to the Dist. Forest Officer, Kamareddy to give clear requisition of Govt. land required for Compensatory Afforestation in lieu of diverted forest lands to various Government projects in the district.

Accordingly, through the reference 5th cited, the RDO, Kamareddy has reported that, the Tahsildar, Bibipet has identified a Govt. land in Sy No: 316/1 Ext: Ac. 50.00 Gts situated at Konapur (V) of Bibipet (M), which is free from encroachment and suitable for compensatory afforestation. Meanwhile, the Dist. Forest Officer, Kamareddy through ref. 6th cited, has given a requisition stating that, an extent of Ac. 38.11 ½ Gts of non forest Govt. land is required for compensatory afforestation. The details are here under;
