

### DETAILED NOTE ON THE PROJECT

Providing BT on road from Balijapally to Karne Tanda from 0/0 to 7/8 Km Ghanpur Mandal, is sanctioned at G.O.Ms.No. 36 for Rs. 4.00 Crores. The work is entrusted to the Agency for the execution.

The Project corridor is an important connectivity between intermandals Wanaparthi Ghanpur & Bijinapally in the state of Telanganarespectively. (Widening and improvement of this section of 0/0 to 7/8 Km would further improve the connectivity in terms of achieving smooth and safe traffic flow and improve level of service. In addition to above, substantial economic gain in terms of reduced Vehicle Operating Cost (VOC) and reduced travel time will be achieved.

The reach from Km 2/3 to 2/8 & 3/5 to 7/2 Km which passes through reserve forest area of Jangamaipally reserve Forest (R.F) and is a part and parcel of 0/0 to 7/8 Km. The existing formation width of the road is 4.00 m which is insufficient to cater the need of the traffic. As such it is proposed to widen the road. The total area of widening is worked out to ~~3.50~~ <sup>3.15</sup> Ha





## CERTIFICATE FOR PAYMENT OF NET PRESENT VALUE
