Adverting to the reference 2<sup>nd</sup> cited, it is informed that ETS & DGPS/ GNSS Survey data, of the forest land proposed for diversion for the following road projects, furnished by Dy. Executive Engineer, PR Division, Sircilla-II Sub-Division has been verified. It is informed that **the ETS & DGPS/GNSS data for the said roads are accepted**. The extents of forest area required for diversion, for which DGPS survey was conducted for each road is detailed below:

2.	Almaspur to Guntapallicheruthada	2.3091 Ha.	
3.	Road from Maddimala to Gundaram	3.9005 Ha.	
4.	Road from Maddimala (ZP Road ) to Somarampet	2.7216 Ha. (estimated with the help of Googleearth for the portion where DGPS survey not conducted)	Geo-coordinates have not recorded for certain portion; to be recorded by UA

It is informed that the proxy RF boundaries depicted on topomaps are used for ascertaining the entry & exit points of alignment with Reserve Forest for each road. The division boundaries are ascertained with the help of available records. The extents are then estimated. **The maps are enclosed herewith.**

Further, Dy. Executive Engineer, PR Division, Sircilla-II, Sub-Division, is informed that for considering any proposal for diversion of forest land under Forest (Conservation) Act, 1980, the User Agency has to make the application online at <http://forestsclearance.nic.in/> alongwith all necessary documents and detailed procedure is available in the form of video.

The hard copies of the proposals alongwith all relevant documents/undertaking /maps duly counter signed by the **Head of the concerned Department** are to be
