> INTENTION & FACT OF THE PROPOSAL

The Proposal for diversion of Forest land for laying of underground pipeline (3 pipeline in one trench) for drinking water to Blue Meadows co-op. HYS Society 21 members houses from Grampanchayat water supply tank & 2 farmers nearby society for agricultural land from back water of 'Panshet Irrigation dam. At- Kauravti, Tal. - Velhe, Dist.—Pune. Grampanchayat has agree

to supply drinking water from their water supply tank. & it is come under Group Grampanchayat Ambegaon Kh. The society has built housed in Gut no 3. At village Kuravati, which is at high altitude.

And area come under Western Ghats hill slop. So there was no availability of water for drinking and also for agri. Irrigation. The back water of Panshet irrigation Dam is only water source available of water supply. But in between the Society land & back water of Panshet irrigation Project. Forest Gut no 3 at village Kuravati Tal.- Velhe. So there is no any alternatives to avid forest area for laying of Underground pipelines for water supply for drinking & agricultural land

To assure water supply for drinking & irrigation to agricultural land, society and farmers together decided to layout underground 4" pvc Pipelines (3 pipelines in one trench).

COST OF THE PROJECT:

Approx. Cost of laying of pipeline proposed work is Rs. 5.00 lacks

> JUSTIFICATION FOR LOCATING THE PROJECT:

Blue meadows Co-op. HYS society Ltd. is in gut no 1 at village -Kuravati, Tal - Velhe, Dist.- Pune. There are 21 members in the HYS & they have built their houses on their allotted plot. This HYS has registered under society act. And register no is PNA/ VHLE /HSG / TO /1104 /2004-05, dt. 11.5.2002. area of HYS is come under Western Ghats hilly area. Total terrain is sloppy and due to high elevating underground water level is very deep, and in summer there are acquit shortage of water supply. HYS has tried tub well but they also can't meet need of drinking & irrigation water to agri. land.

The back water of 'Panshet irrigation Dam' is only water source available for water supply, which is about 500 to 700 mt below from the HYS area. To assure water supply for drinking & irrigation to agricultural land, society and farmers together decided to layout underground 4" pvc pipelines (3 pipelines in one trench).

After detailed survey to laydown pipeline of drinking water supply from Grampanchayat tank, & irrigation water from the back water of 'Panshet irrigation Dam', it is observed that proposed pipeline will be passing from the forest Gut no 3 at village- Kuravati, Group Grampanchayat is agree to provide drinking water from their drinking water tank. And E.F Panshet Irrigation Project has sanctioned Pani Parvana for agri. Irrigation for period of 18 years.

HYS Society 21 member's houses from Grampanchayat water supply tank & farmers nearby society for agricultural land from back water of 'Parana Irrigation dam'. At- Kuravati, Tal. - Velhe, Dist.—Pune. Grampanchayat has agree to provide drinking water from their water supply tank. & it is come under Group Grampanchayat Ambegaon Kh. Tal. _Velhe, Dist.- Pune. The society has built housed & two drinking water tanks in Gut no 1. At village Kuravati, which is at high altitude.

Proposed pipeline passing through the Forest Gut no 3 at village- Kuravati Tal- Velhe, & there is no any other alternatives to avid forest area for laying of Underground pipelines for water supply for drinking & irrigation to agricultural land

The project authority was aware of the fact that, such forest lands have come under purview of the provisions of the Forest (Conservation) Act, 1980. Hence this proposal is being submitted for necessary clearance under the provision of the Forest (Conservation) Act, 1980
