Panchayat's No Objection Certificate has not been given. FRA certificate to be issued by Collector has not been attached.	As per MoEF guideline Dt 05.02.2013 & 26.02.2019[Annexure-B]. FRA certificate is to be submitted within the time period stipulated for compliance of Stage-I condition. As clarified in the above guideline FRA is not required for consideration of in-principle approval. Accordingly we undertake to comply with FRA post grant of in-principle approval.
