Anent to the above subject, the request of IIT Dharwad regarding issuing of NOC / Permission from KPTCL for thoroughfare under the existing 110 kV transmission line corridor, which passes through reserve forest area, for their approach road, connecting two regions within IIT campus has been examined.

In this regard, I am directed to communicate approval to issue necessary NOC / Permission to IIT Dharwad for normal thoroughfare as an approach road based on the report furnished from your office and opinion of Chief Engineer (Electy) (Planning & Co-ordination) office, subject to the following conditions.

- Access to normal thoroughfare in the existing corridor requires any alteration / modification shall be carried out by IIT Dharwad under self execution basis (if required) duly obtaining written permission from concerned KPTCL officials.
- Any activity to be taken up by IIT Dharwad underneath the line or adjacent to the existing line safety measures to be maintained as per CEA regulations.

3. The Right of Way (ROW) of 110kV line corridor remains with KPTCL.

 KPTCL will not be held responsible for occurrence of any untoward incidents due to not adhering to the CEA regulations / conditions.
