In inviting a kind reference to the letter on the subject cited above, the point wise compliance/clarification to the EDS made by your office is submitted herewith for kind information and necessary action.

# Observation-1

Check list should be properly filled in mentioning the page number and all necessary undertaking required as per check list should be enclosed. Copy of the Check list is enclosed herewith for reference.

Compliance

The standard check list prepared by PCCF, Odisha under Forest Conservation Act, 1980 is properly filled and all necessary undertakings required for the project is provided in the DP.

#### Observation-2

All papers/pages should be signed by the Authorized Signatory of the User Agency.

Compliance:

All papers/pages have been signed by the authorized signatory of the User Agency.

# Observation-3

Certificates(NoC) from concern District Magistrates under the Forest Right Act'2006 are to be furnished.

Compliance:

The FRA Certificate over an area of 0.409ha under Forest Right Act, 2008 has been issued by Collectore, Sundargarh vide his memo no.3936 dated 05.12.2018 to your Office.

### Observation-4

The letter of technical approval of the project should be enclosed.

Compliance:

Thetechnical approval of the project is enclosed at page No 44of the DP.

### Observation-5

In the Diversion Proposal you have mentioned that an area of 27.796ha of non-forest land identified in Barkate Range of Deogarh Forest Division. The Copy of CA Scheme should be enclosed in the diversion proposal.

# Compliance:

The non-Forest land over an area of 27.796 ha has been identified in Barkote Range of Deogarh Forest Division for the purpose of Compensatory Afforestation. The CA scheme will be communicated to your office by DFO, Deogarh after its formulation during his proposal forwarding to RCCF, Rourkela.

#### Observation-6

As per your online and offline application, you have mentioned that the clearance uder Environment (Protection) Act, 1980 is required of the above project. The Environmental Clerance should be enclosed in the Diversion proposal.

# Compliance:

The Environmental Clerance is enclosed at page no 30 in the Diversion proposal.

#### Observation-7

In item No. 2 of part-I (offline) it appears that the purpose-wise break up land required for the entire project have been mentioned, and the details of forest and non-Forest land applied to be diverted in Bonai Forest Division have not been mentioned.

Hence, the purpose-wise break up of land pertaining to Bonai Division should be mentioned in the given proforma separately in addition to the breakup of land entire project has already mentioned.

# Compliance:

The purpose-wise break up of land pertaining to Bonai Division and the details of forest and non-Forest land applied to be diverted in Bonai Forest Division is attached at Page No. 15 of DP.

# Observation-8

The following Certificate is to be obtained from the concerned Tahasildars and enclosed to the DP as required vide Letter No. 4822 dt.12.02.2015 of the Chief Secretary of Odisha.

"Certified that the status of total land in the project (both Forest & Non-Forest) as given in the table is as per as per Govt. Record as on 25.10.1980."

#### Compliance

The said certificate signed by the Tahasildar Lahunipada is attached at Page. No 45 of the DP.

### Observation-9

The abstract of land Schedule of Non-forest land of Banki Village signed by the User Agency and the Range OfficerKuliposh, duly authenticated by the concerned Tahsildar should be enclosed.

# Compliance:

The authenticated land schedule of the non-forest land of village Banki and the land abstract signed by Range Officer, Kuliposh and Tahasildar, Lahunipada along with the user agency is attached at Page.No 21 of the Proposal.

#### Observation-10

The land schedule of PRF along with abstract should be signed by the User Agency, and authenticated by the concerned Range Officer.

# Compliance:

No PRF is coming under the proposed Kala Barrage alignment in this division.

# Observation-11

Statement of R.F land along with abstract signed by the User Agency and authenticated by the concerned Range Officer, Kuliposh should be enclosed.

# Compliance:

No RF is coming under the proposed Kala Barrage alignment in this division.

# Observation-12

The applied area of Bonai Division show in the Topo Sheet Map should be signed by the User Agency and authenticated by Range Officer, Kuliposh Range.

# Compliance:

The applied area of diversion in Bonai Forest Division shown in the Topo Sheet signed by the User Agency authenticated by the Tahasildars, Lahunipada and Range Officer, Kuliposh Range is placed at Plate No-A in the DP.

#### Observation-13

The applied area of Bonai Division comes to 1.010Ac (Or 0.409 Ha) as per online application. But as per DGPS Map, an area of 0.408 ha has been mentioned instead of 0.409ha the same should be corrected accordingly.

# Compliance:

The area of all the DGPS Maps has been corrected accordingly.

# Observation-14

The DGPS Map of Sundargarh of Bonai Division has been authenticated by the Range officer, Barkote, Tehsildar, Barkotend Amin Tehsil Office Barkote. The above index DGPS Map should be signed by the User Agency and the Range OfficerKullposh, Tehsildar, Lahunipada and enclosed to Diversion Proposal.

# Compliance:

All the DGPS Maps along with co-ordinates of the area applied for Diversion are authenticated by the concerned Range Officer, Kuliposh and Tahsildars, Lahunipada is placed in the Dp.

# Observation-15

The name of all villages on which the applied area in Bonai Division should be mentioned in Part-1. Compliance:

The project area in Bonai Forest Division passes though 1 village that is Banki the name of the village is mentioned in Part-I of the Proposal.

#### Observation-16

The Proposal should be serially page numbered with Annexure numbering.

The proposal is serially numbered and annexure is mentioned.
