Sir,

In inviting a kind reference to the subject cited above, it is to state that an e-filling was completed on the web portal of MoEF & CC for diversion of an area of 27.668 ha covering two forest divisions i.e. Deogarh and Bonai. The proposal bearing Sl.No.FP/OR/IRRIG/34120/2018 has been forwarded by your good office vide State Sl.No.OR-33/2018 dt-21.6.2018 to respective DFO's for further necessary action at their end. The proposal has been submitted by both the Divisional Forest Offices to the RCCF office at Rourkela after completing necessary process.

During scrutiny at RCCF level, it was found that, some of the non-forest Govt. plots are coming under Sabik kissam jungle and the proposal forest area has been increased from 27.668 ha to 30.630 ha. Simultaneously, the proposal with necessary correction has been resubmitted by this office to the RCCF, Rourkela through respective DFOs. But the online area can not be edited due to technical issues. As per discussion with the NIC, New Delhi officials, it is required to withdraw the proposal for revised forest area.

In view of this, it may kindly be considered to withdraw the above said proposal from on-line portal, so that further steps will be taken to apply a fresh proposal with the revised forest area of 30.630 ha.
