I am directed to refer to ONGC's letters no. dated 12.10.2012 and 07.11.2012 on the aforesaid subject and to convey approval of Government of India for Grant of Petroleum Mining Lease (PML) in respect of 21 Blocks (10 Onland and 11 Offshore) of ONGC for a period of 7 years under Rule 5 (1) (ii) of the Petroleum and Natural Gas Rules, 1959 (as amended from time to time) from the date of issue of this order for Offshore Blocks and ~~from the date of issue of lease order by concerned State Government for Onshore Blocks~~, as the case may be, for areas as per details mentioned below: -

2. The Lease for all the 21 Blocks is subject to all the terms and conditions stipulated in Oil Fields (Regulation and Development) Act, 1948 and the Petroleum and Natural Gas (P&NG) Rules, 1959 made thereunder as amended from time to time.

3. ONGC shall provide Appendix "A" containing geographical limits of the areas for which lease has been granted to the Ministry and others concerned in respect of Onland Blocks and shall also provide for Offshore Blocks Appendix "A" containing geographical limits, Appendix "B" containing relevant datas and Appendix "C" containing intimation regarding award of contracts to parties and details as per prescribed format to the Ministry and others concerned with in a period of 10 days positively

4. The Lease for all the 21 Blocks shall be subject to the following conditions: -

- (i) The lease shall be subject to the completion of commitments made by ONGC.
- (ii) The lease shall not be re-granted unless ONGC make the discoveries and monetise them during this period of PML.

5. This issues with the approval of Secretary (P&NG).
