:- The Proposal is for diversion of 49.69 Hects of forest land for improvement/ construction of 2 lanning road from Demwe - Brahmakund road section of Demwe - Hawai road. Recognising the need for the development of road connectivity in NE Region, MoRTH embarked upon plan for road network in the region. The road is a section of Tezu - Hawai road which is strategically important owing to its proximity to Indo - China Border, which is less than 100 Km in aerial distance and the only road available at present to pproach trijunction point of China, India and Myanmar Border.
